Detailed terms and conditions of EOI for providing manpower services to the Regional Office of RailTel Corporation, Secunderabad are enclosed. The EOI document can be obtained from the office of **RailTel Corporation of India Ltd.**, 2nd floor, B-Block, Rail Nilayam, Secunderabad-500 071 at a cost of Rs.2000/- till 27.06.2016 12.00 hrs or can be downloaded from RailTel's official website (www.railtelindia.com). If downloaded, a fee of Rs. 2000/- (Rupees Two Thousand only), inclusive of applicable VAT towards the cost of the document, should be paid separately. An Earnest Money Deposit (EMD) as mentioned above for each Territory office should be deposited in the form of Demand Draft (in addition to the DD for Rs.2000/-, if EOI is downloaded) drawn in favour of "RailTel Corporation of India Limited" payable at Secunderabad and submitted along with the proposal in sealed cover.

If participation is for more Eols (more territories), the Eol document shall be separately submitted for each case with necessary EMD, cost of document if downloaded from website and the enclosures with each Eol document for evaluation of offer.

The duly completed proposal will be received in the Regional Office of RailTel Corporation of India Ltd. at 2nd floor, B-Block, Rail Nilayam, Secunderabad-500 071 till 15.00 hours of **27.06.2016** and the same will be opened on the same date at 15.30 hours at the same place. In case 27.06.2016 is declared holiday, the EOI proposals will be opened on the next working day at 15.30 hours. RailTel Corporation reserves the right to reject any or all the EOI proposals without assigning any reason(s) there for. The offers are deemed to be valid for acceptance for a period of 90 days from the date of opening of the tender. Late/delayed/ incomplete tenders and tenders with insufficient cost of tender# /EMD* will be summarily rejected.

Note: #*

- i. Small Scale Units registered with **NSIC** under single point registration scheme shall be exempted from the cost of tender documents. However, postage charges of Rs. 500/- would have to be paid by them, in case they need tender document by post.
- ii. They are also exempted from submission of EMD
- iii. These exemptions shall be applicable provided units are registered with NSIC for tendered item and registration is current and valid. Firms claiming these exemptions are required to submit along with their offer, a copy of their current and valid NSIC registration certificate for the tendered item/items, otherwise their offer would not be considered
