

The tenderer has also to submit their TIN No., PAN No. & Service Tax No. at the time of submissions of their "on account bills. In addition to it, the contractor should submit copy of WCT registration certificate for the states wherever applicable. Act & ESI registration no. should also be available with the contractor. All the statutory provisions have to be made by the contractor.	
i)	This tender invited for carrying out the O&M works through different tenders pertaining to different sections (10 nos of section) of Western Region. The total cost mentioned in the tender notice is total sum of cost of all the tendered sections.	

Small Scale Units, if registered with NSIC for the item tendered, under single point registration scheme, copy of valid registration certificate for exemption of tender cost, is to be submitted. However, postage charges of Rs. 500/- would have to be paid by them, in case they need tender document by post.

The offers shall be opened on above said date in the presence of those bidders who choose to be present. If the above said date happens to be a holiday the same shall be opened on the next working day.
