3.5.8 NSIC Registered firm

Small scale units registered with NSIC under single point registration scheme and participating in this tender following exemption shall be available i) They shall be exempted from cost of tender document. However postage charges of Rs. 500/- would have to be paid by them, in case they need tender document by post. ii) They shall also be exempted from depositing Earnest money. In case firm is registered with NSIC copy of valid registration certificate with same scope of work as NIT for exemption of EMD, is to be submitted. These exemptions shall be applicable provided units are registered with NSIC for tendered item and registration is current and valid. Firm claiming these exemptions are required to submit copy of valid registration certificate with same scope of work as NIT, along with their offer otherwise their offer would not be considered
