- 1.3 Tender forms are not transferable.
- 1.4 Tenders in sealed cover, super-scribing the Tender Notice No & dt. Name of work for which tender submitted with the address of the tenderer addressed to Executive Director, Eastern Region, RailTel Corporation of India Ltd., Eastern Region, 3<sup>rd</sup> Floor, Chatterjee International Centre, 33A Jawaharlal Nehru Road, Kolkata 700071 can be dropped in the tender box kept in the above mentioned office and also be sent by post/courier to reach by scheduled time of closing of tender. RailTel will not be responsible for Postal/courier delay and transit loss. The Tender Box will remain open from 10:00 hrs to 15:00 Hrs upto the date of tender opening.
- 2.1 The following further documents may be submitted along with tender:

  List of personnel in the organization available on Hand and proposed to be engaged for this subject work. These two list should be given separately and signed by the tenderer.
  - List of Plant & Machinery available on hand (own) and proposed to be inducted (own and hired to be given separately) for the subject work and each page of this list shall be signed by the tenderer.
  - List of works completed in the last three financial years of this current financial year giving description of work ,organization for whom executed, approximate value of contract at the time of award ,date of award and date of scheduled completion of work, date of actual start & actual completion of work and final value of contract should also be given.
- 2.2 Any change or modification in the constitution of tendering firms for whatever purpose or intimation of any dispute by any of the partners in the firm, making the tendering firm ineligible, during consideration of the tender after opening of tender, shall be deemed to be backing out of the offer by the tenderer.

3. The EMD should be paid in form of DD issued by Nationalised banks/or scheduled bank in favour of RailTel Corporation of India Ltd. payable at Kolkata.

4. Tender offers not accompanying with the requisite Earnest Money

Deposit shall be summarily rejected.

5. Tenderer shall deposit earnest money and Cost of tender Document in the form of Bank Demand Draft drawn in favour of RailTel Corporation of India Limited payable at Kolkata, separately for each tender/section.

The tender not accompanied by Cost of Tender Document and Earnest Money as mentioned above will be summarily rejected.

For Small Scale Units registered with NSIC under single point registration scheme and participating in this tender, following exemptions shall be available

- (i) They shall be exempted from cost of tender documents. However, postage charges of Rs. 500/- would have to be paid by them, in case they need tender document post.
- (ii) They shall also be exempted from depositing Earnest money.

This exemption shall be applicable provided units are registered with NSIC for tendered item and registration is current and valid. Firms, clamming these exemptions, are required to submit along with their offer, a copy of their current and valid NSIC registration certificate for the tendered item/items; otherwise their offer would not be considered.

6. The tenders will be opened in the presence of those tenderers who can make it convenient to be present (only one representative of the tenderer) with proper authentication letter in the Tender Hall. In case, the date of Opening of the tender happens to be holiday; the same will be opened at the same time on the next working day.
