For Small Scale Units registered with NSIC under single point registration scheme and participating in this tender, following exemptions shall be available

- (i) They shall be exempted from cost of tender documents. However, postage charges of Rs. 500/would have to be paid by them, in case they need tender document by post.
- (ii) They shall also be exempted from depositing Earnest money.

This exemptions shall be applicable provided units are registered with NSIC for tendered item and registration is current and valid. Firms, clamming these exemptions, are required to submit along with their offer, a copy of their current and valid NSIC registration certificate for the tendered item/items; otherwise their offer would not be considered.

Providing car for each States/State HQs/District HQs. shall be treated as a separate tender. However, a bidder may quote for multiple States/State HQ/ District HQs in one tender document but the cost of the tender document shall have to be submitted for each State/ State HQ/ District HQs section in which he has participated.

Fulfillment of eligibility criteria as mentioned in the tender document is a pre-requisite for consideration of the offer of the tenderer. If a tenderer submits offers for more than one States/ State HQ/ District HQs, then the sum total of the credentials required for each State/State HQ/ District HQs in which participated shall have to be fulfilled by the tenderer for qualifying in the States/State HQs/ District HQs participated. In case of part fulfillment of this criterion, RailTel shall, at its discretion, discard any of the offers for the State/State HQ participated by the tenderer and take into consideration any of the Sates whose total eligibility criteria requirement matches with those available with the tenderer.

The rates quoted by the tenderer in a State shall have no bearing on the rates quoted by him for any other States. Each State shall be treated as a separate tender and the tender finalized accordingly. For the purposes of arriving at the valid lowest rate, each section shall be considered as a separate entity.

The offers shall be opened on above mentioned date in the presence of those bidders who choose to be present. If the receipt/opening bid date happens to be a holiday, the same shall be done on the next working day.
