21.8 The price quoted by the bidder shall remain fixed during the entire period of contract and shall not be subject to variation on any account.

21.8 i) The imposition of any new tax and /or increase in the aforesaid taxes, duties levies (including fresh imposition of any other Tax like Goods and Service Tax subsuming the indirect taxes like excise, VAT, service Tax etc.,), after the last stipulated date for the receipt of tender including extension if any and the bidder thereupon necessarily and properly pays such taxes/Levies/ Cess, the bidder shall be reimbursed the amount so paid, provided such payments, if any, is not, in the opinion of RailTel attributable to delay in execution of work within the control of bidder.
