GST will not be reimbursed in the absence of proper invoice for availing input tax credit.</p> <p><b>iii)</b> The break-up of price of each item of SOR in terms basic Unit price, Excise duty, Sales tax, Freight, custom Duty, Forwarding, Packing, Insurance and any other Levies/Charges already paid or payable by the bidder shall be quoted in the SOR. Bidder has to quote all-inclusive rates (with tax break-up). Even after the introduction of GST, all inclusive unit rates payable will not exceed the all-inclusive rates offered by the bidder. However if rates are reduced in the current tax structure the bidder has to pass on the benefit to RailTel.</p>
