1.4 Tenders in sealed cover, super-scribing the Tender Notice No & date, Name of the work for which tender submitted with the address of the tenderer addressed to Executive Director, Eastern Region, RailTel Corporation of India Ltd., Eastern Region, 3rd Floor, Chatterjee International Centre, 33A Jawaharlal Nehru Road, Kolkata – 700071 can be dropped in the tender box kept in the above mentioned office or can also be sent by post/courier to reach by scheduled time of opening of tender. RailTel will not be responsible for Postal/courier delay and transit loss.The Tender Box will remain open from 10:00 hrs to 15:00 hrs till the date of tender opening.

2. The EMD should be paid in the form of Pay Order/ DD issued by Nationalised banks/or scheduled bank in favour of RailTel Corporation of India Ltd. payable at Kolkata.
3. Tender offers not accompanying with the requisite Earnest Money Deposit, Cost of Tender Document shall be summarily rejected.
4. For Small Scale Units registered with NSIC under single point registration scheme and participating in this tender, they shall be exempted from depositing Earnest money& COST OF tender document.

This exemptions shall be applicable provided units are registered with NSIC for tendered item and registration is current and valid. Firms, claiming these exemptions, are required to submit along with their offer, a copy of their current and valid NSIC registration certificate for the tendered item/items; otherwise their offer would not be considered.

5. The tenders will be opened in the presence of those tenderers who can make it convenient to be present (only one representative of the tenderer) in the Tender Hall. In case, the date of Opening of the tender happens to be a holiday, the same will be opened at the same time on the next working day.
