With reference to subject matter, following amendments to the EOI document are issued. The EOI response may be submitted in consideration to these amendments. **All other terms and conditions will remain unchanged.**

1. Notice Inviting Expression of Interest (EOI) at Page-2 of EOI Document

Para 2; "RailTel Corporation of India Limited will not contribute any fund to empanelled agencies for the program. Interested Organization, who are already working in field of Livelihood Development/Skill & Training/Income Generation Project for underprivileged community (especially in rural area) may respond to the EOI".

is amended as:

"Interested Organization, who are already working in field of Livelihood Development/Skill & Training/Income Generation Project for underprivileged community (especially in rural area) may respond to the EOI".

2. Adding point no. "i" under Annexure-B Point No. 1

Program Manager should also ensure that RailWire Saathi should not cause "loss/damage" to Railway properties or any third party. In case of an "anti-social behavior" of Saathi, his/her association with RailTel shall be terminated immediately.

3. Adding point no. "j" as a "Financial Model" under Annexure-B Point No. 1

(1) One Time Cost (OTC):

(i) One Time Cost of Rs. 20,000/- per station will be provided to Program Manager as One-Time initial expenditure support related to induction, training and initial handholding cost for RailWire Saathi.

(ii) A amount of Rs. 3,000 will be provided to per RailWire Saathi per month for initial 3 months through respective Program Manager's as gestation period. In case of replacement of Saathi due to any reason, the gestation period Financial support will not be applicable. Program Manager will provide proof of disbursement of gestation period Financial support to RailTel of their respective allotted stations.

(2) Revenue Sharing

The Program Manager will have the responsibility of managing RailWire Saathi for the entire duration of the program and the IT H/W which will be provided to Saathis for their respective stations allotted to them.

A Revenue Share of 05% of the total income earned (equal to or more than Rs. 5,000/- per month) by the RailWire Saathi on monthly basis will be provided to Program Manager (ex. If monthly earning of RailWire Saathi is Rs. 20,000/-then the revenue share of Program Manager will be 05% i.e. Rs. 1,000/-).

For the period RailWire Saathi earning is less than Rs. 5,000/- per month, then no revenue share will be applicable for Program Manager.

4. Adding point no. "k" as a "Performance Bank Guarantee" under Annexure-B Point No. 1

The successful bidder shall submit the Performance Bank Guarantee to RailTel for an amount equal to Rs 1 Lakhs within 30 days of award of letter of empanelment. The Performance Bank Guarantee shall be valid for 6 months beyond the expiry of agreement i.e. 3.5 years.

The Performance Bank Guarantee may be discharged by RAILTEL upon being satisfied that there has been due performance of the obligations of the successful bidder under the agreement. Failure of the successful bidder to comply with the requirement as per the EOI terms and conditions shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security.
