## CHAPTER III

### Commercial Terms & Conditions GENERAL CONTRACT TERMS & CONDITIONS

#### 1. General instructions

- 1.1 Tenders are invited on behalf of RailTel Corporation of India Limited, Western Region, and Mumbai from Original Equipment Manufacturers (OEMs) of tendered item as detailed in SOR (Chapter II).
- 1.2 In case any manufacturer(s) does not market their product(s) directly, then such manufacturer(s) may submit their offer along with documents for their being manufacturer through their Authorized Marketing outlet. In such case authorization certificate (duly attested by Public Notary) valid on due date of tender opening or authenticated letter in original specifying the tender reference in the name of tenderer from manufacturer for the tendered item should be submitted by the tenderer along with the offer.

#### 2. Description of item

As per Schedule of Requirement.

#### 3. A: Scope of Work:

The broad responsibility of the contractor under the scope of work for this tender shall be as under:

- i. Supply of item confirming to Specifications & requirements specified in tender document & as per 'Schedule of Requirement'.

#### B: Eligibility Criteria:

- I. The tenderer should have executed single order for a minimum value of 35% of advertised tender value for similar work to Central government agencies, State Government, PSU or any reputed TELCO in the last three financial year (i.e. current year and three previous financial year). **The contractor should submit the supply confirmation certificate from the user.**  
# **Similar work-** The work for Supply of Optical Fibre Splicing (Joint) Enclosures (24F) in any Government / State Government/PSU/reputed Telco..
- II. The sum total of the turnover (contract amount) during the last preceding three financial years (i.e. current year and three previous financial year) up to the date of opening of tender should be a minimum of 150% of advertised tender value of work. **The audited Balance Sheets and Profit & Loss statements are to be submitted.**

#### 4. Offer letter and Validity of Offer

- 1.1 The bidder shall complete the offer letter and the price schedule furnished in the bid documents, indicating the goods to be supplied, description of the goods, associated

technical literature, quantity and prices etc. For the items not manufactured by bidders, the authorization from original manufacturer should be enclosed.

- 1.2 Bidder should enclose their credentials including supply of similar material to other government/PSUs/ Telecom Service Providers.
- 1.3 The GST registration is required to avail GST Credit, tenderer should be registered with Concerned department. The documentary evidence for the same should be enclosed along with the offer. However, in absence of documentary evidence or certificate, the offer is summarily rejected.
- 1.4 The bidder should fulfill the complete Technical specifications as per Chapter-IV.
- 1.5 The offer should remain valid for a period of **20** days from the date of opening.
- 1.6 The Splice Joint Enclosure shall be approve against the technical specifications as per TEC GR mentioned in the table below and the valid TAC/TSEC of the quoted items of accessories shall be submitted along with the bid .TSEC obtained against BBNL tender no BBNL/MM/2013/001 issued on 03.04.3013 will be acceptable. For Joint closures the bidder may quote for such models of accessories for which, TSEC in QF-103 Form to Quality Assurance Circle, Bengaluru or in Form-B to TEC, New Delhi have been applied for against the technical specifications as per respective TEC GRs at least one day before the opening of the tender. The registration number allotted for TSEC purpose by QA circle BSNL Bengaluru or for TAC New Delhi Shall be submitted along with the bid. However only type approved accessories as per below specification, will be accepted, which will have to obtained before placement of PO. If the bidder is not the manufacturer of such tendered items , then the bidder shall enter into legally binding agreement(s) with manufactures of the tendered items and the copy of such agreement(s) shall be furnished with the bid. It shall be bidder's responsibility to ensure timely availability of valid TSEC/TAC against third-party products.

- 1.7. The tenderers shall submit a notarized affidavit on a non-judicial stamp paper stating that they are not liable to be disqualified and all their statements/documents submitted along with bid are true and factual. Standard format of the affidavit to be submitted by the bidder is enclosed as **Annexure-6. Non submission of an affidavit by the bidder shall result in summarily rejection of his/their bid.** And it shall be mandatorily incumbent upon the tenderer to identify, state and submit the supporting documents duly self attested by which they/he is qualifying the qualifying criteria mentioned in the Tender Document.

- a. The RailTel reserves the right to verify all statements, information and documents submitted by the bidder in his tender offer, and the bidder shall when so required by the RailTel, make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by the RailTel Shall not relieve the bidder of its obligations or liabilities here under nor will it affect any rights of the RailTel there under.
- b. In case of any wrong information submitted by the tenderer, the contract shall be terminated , Earnest Money Deposit (EMD), Performance Guarantee (PG) and Security Deposit (SD) of contract forfeited and agency barred for doing business on entire RailTel for 5 (Five) years.

### **Warranty**

- 5.1** The contractor shall warrant that stores to be supplied shall be new and free from all defects and faults in material, workmanship and manufacture and shall be of the highest grade and consistent with the established and generally accepted standards of materials of the type ordered and shall perform in full conformity with the specifications. The contractor shall be responsible for any defects that may develop under the conditions provided by the contract and under proper use, arising from faulty materials, design or workmanship such as corrosion of the equipment, inadequate quantity of material to meet equipment requirements, inadequate contract protection, deficiencies in circuit design and or otherwise and shall remedy such defects at his own cost when called upon to do so by the Purchaser who shall state in writing in what respect the stores are faulty.
- 5.2** The contractor shall give warranty of materials supplied by them for a period of **12 months** from date of receipt of materials.
- 5.3** If it becomes necessary for the contractor to replace any defective materials under this clause, the provisions of the clause shall apply to the materials so replaced or renewed or until the end of the warranty period of 12 months from of receipt of material.
- 5.4** Replacement under warranty clause shall be made by the contractor free of all charges at site including freight, insurance and other incidental charges.
- 5. Delivery of material:**

## 6. Payment Terms

**7.1 90%** on supply of materials at site duly inspected and accompanied with the following documents:

- Invoice: Tax Invoice as per GST Provision.
- Tax Invoices shall have clear bifurcation of basic price and GST, indicating the break-up of the GST for availing CENVAT Credit.
- The Tax Invoices shall be raised state wise(place of service and supply) in the name of:

- Indicating the place of supply and shall be submitted at Mumbai.
- All Tax Invoices raised should be serially numbered as per GST provision.
- GST No. of RailTel & Vendor should be mentioned on the face of the Tax Invoices.
- Vendor should comply all provision of CGST/SGST/UGST Act.
- Paying Authority: Deputy General Manager /F/WR/Mumbai.
- All statutory taxes applicable as per the rules (if applicable) shall be deducted at source from your bills.

- All payment shall be made in Indian Rupees only.
- Delivery Challan duly accepted by Consignee.
- Inspection certificate
- Warranty certificate of OEM/Supplier as per warranty clause 5.
- All payments to be made directly to the Contractor through Online payment mode. For this purpose, the Contractor shall submit details of Bank Account as per RailTel's standard format. RailTel shall be entitled to deduct Income Tax in case applicable and other taxes at source in accordance with the provision of Income Tax Act/other taxation laws as applicable from time to time. In case of deduction necessary TDS certificates shall be issued by RailTel

7.2 Balance 10% value of the PO on full supply at site and on receipt by the consignee.

## **7. Performance Bank Guarantee (PBG)**

7.1. (i) The supplier is required to submit a Performance Bank Guarantee (PBG) within 30 days of issue of Letter of Acceptance for 10 % of the value of the LOA. The PBG shall be valid for a period of 2 months beyond warranty period towards satisfactory performance of contract. The PBG shall be returned after successful completion of contractual obligation for Supply and acceptance of material duly accepted by consignee including warranty period. The Proforma for PBG is given in Chapter V – Annexure -1. If PBG submission is delayed beyond 15 days up to 30 days, penalty @15% p.a. over PBG amount will be levied. However, if PBG submission is delayed by more than 30 days, penalty @30% p.a. over PBG amount will be levied.

(ii) A separate advice of Performance Bank Guarantee (PBG) will invariably be sent by PBG issuing bank to the RailTel's Bank through Structured Financial Messaging System (SFMS) and only after this, the PBG will become acceptable to RailTel. It is therefore in own interest of successful bidder to obtain RailTel's bank IFSC Code, its branch and address and advice these particulars to the PBG issuing bank and request them to send advice of PBG through SFMS to the RailTel's bank.

8.2 The value of P.B.G. to be submitted by the contractor will not change for variation up to 25% (either increase or decrease). In case during the course of execution, value of the contract increases by more than 25% of the original contract value, an additional Performance Bank Guarantee amounting to 5% (five percent) for the excess value over the original contract value shall be deposited by the contractor.

8.3 The PBG will be forfeited if the order is terminated by the purchaser on account of Contractor.

## **8. Taxes & Duties**

## **9. Liquidated Damages**

The timely delivery is the essence of this project. Liquidated damages will be applicable at the rate of half percent per week or part thereof for undelivered portion subject to a maximum of 10 % of the cost of supply. RailTel will have the right to cancel the order, place order on alternative source besides levying the L.D. In such case the PBG will be forfeited and the tenderer will not be allowed to participate in the tender. The competent Authority while



granting extension of currency of the contract may also levy token penalty as deemed fit based on the merit cases.

**10. Transportation**

The rates quoted should be F.O.R. destination.

**12. Statutory Deduction**

These will be made at source as per the rules prevalent in the area of work.

**13. Issue of Purchase Order/Award of Contract**

The purchaser shall consider placement of orders for commercial supplies on those bidder whose offers have been found technically and commercially acceptable and are lowest. The issue of Letter of Acceptance shall constitute the award of contract on the bidder. The bidder shall, within 15 days of issue of Letter of Acceptance, give his acceptance along with Performance Bank Guarantee as per Clause 8 and sign the Agreement within 15 days of issue of Letter of Acceptance as per Performa in Chapter V - Annexure -2.

**14. Purchaser's Right to Vary Quantities**

14.1 Unless otherwise specified in the special conditions of the contract, the accepted variation in quantity of each individual item of the contract would be up to 25% of the quantity originally contracted. The contractor shall be bound to carry out the supply at the agreed rates and shall not be entitled to any claim or any compensation whatsoever up to the limit of 25% variation in quantity of individual item of supply.

14.2 Quantities operated in excess of 125% but up to 140% of the agreement quantity of the concerned item shall be paid 98% of the rate awarded for that item in this tender.

14.3 Quantities operated in excess of 140% but up to 150% of the agreement quantity of the concerned item shall be paid at 96% of the rate awarded for that item in this tender.

14.4 Variation in quantities of individual items beyond 150% will be executed through fresh tenders or by negotiating with the existing contractor with finance concurrence and approval of competent authority.

14.5 For decrease beyond 25% for individual items, finance concurrence and approval of competent authority shall be taken after obtaining "No Claim Certificate" from the contractor.

**15. Splitting of Order**

**16. Purchaser's Right to accept any Bid and to reject any or all Bids**

The purchaser reserves the right to accept or reject any Bid and to annul the bidding process and reject all bids, at any time prior to award of contract without any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Purchaser's action.

Failure of the successful bidder to comply with the requirement of Clause 8 shall constitute sufficient ground for the annulment of the award and forfeiture of EMD in which event the Purchaser may make the award to any other bidder at the discretion of the Purchaser or call for new bids.

**20. Earnest Money Deposit (EMD)**

- i. Earnest Money as per Tender Notice shall be submitted in the form of Pay Order/ Demand Draft from any Nationalized/Scheduled bank in India in favor of **“NOFN EXPENDITURE CURRENT ACCOUNT WR” payable at Mumbai.**
- ii. The EMD may be forfeited if a bidder withdraws his offer or modifies the terms and conditions of the offer before validity period and in the case of a successful bidder, if the bidder fails to accept the Letter of Acceptance and not furnishing performance security in accordance with clause 8 & 13.
- iii. Tenders not accompanied by Earnest Money shall be summarily rejected.
- iv. Earnest Money of the unsuccessful bidder will be discharged/returned as promptly as possible.
- v. The successful bidder's EMD will be discharged upon the bidder's acceptance of the Letter of Acceptance satisfactorily and furnishing Performance Bank Guarantee in accordance with Clause 8.
- vi. For NSIC registered firm:  
Small scale units registered with NSIC under single point registration scheme or registered as Micro, Small and Medium Enterprises under MSMED Act 2006 with District Industries Centres or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or Directorate of Handicrafts & Handloom or any other body specified by Ministry of Micro, Small & Medium Enterprise and participating in this tender following exemption shall be available i) They shall be exempted from cost of tender document. However postage charges of Rs. 500/- would have to be paid by them, in case they need tender document by post. ii) They shall also be exempted from depositing Earnest money. In case firm is registered with NSIC or under MSMED copy of valid registration certificate with same scope of work as NIT for exemption of EMD, is to be submitted. These exemptions shall be applicable provided units are registered with NSIC or under MSMED for tendered item and registration is current and valid. Firm claiming these exemptions are required to submit copy of valid registration certificate with same scope of work as NIT, along with their offer otherwise their offer would not be considered.

**21. BID PRICES, Taxes & Duties**

- 21.1 The bidder shall give the total composite price inclusive of all levies and taxes, packing, forwarding, freight and insurance etc. **The basic unit price and all other components of price need to be individually indicated against the goods it proposes to supply under the tender as per schedule given in Chapter II.** The price shall be firm in Indian Rupees and FOR Destination. No Foreign exchange will be made available by the purchaser.

21.2 The breakup of price of each item of SOR in terms of basic Unit price, GST, Freight, Forwarding, Packing, Insurance and any other Levies/charges already paid or payable by the supplier shall also be quoted separately.

21.3 Any change in statutory duties/taxes, in position /removal of any duty/taxes shall be to RailTel's account. In case of the successful tenderer is not liable to be registered under CGST/IGST/UTGST/SGST Act, the RailTel shall deducted the applicable GST from his/their bill under RCM and deposit the same to the concerned tax authority.

## **22. Clause wise Compliance**

## **23. Provenness of the material/equipment supplied:**

In order to enable the Purchaser to assess the proven-ness of the system offered, the bidder shall provide documentary evidence regarding the satisfactory performance of the material supplied and services rendered by him like Manufacturer's test cum Guarantee certificate.

## **25. Inspection**

25.1 Pre-shipment/pre-dispatch inspection shall be carried out at manufacturer's / supplier's works by authorized representative of RailTel's. The materials should be offered for inspection within 2 to 3 weeks of issue of Purchase Order. Traveling, lodging & boarding expenses of RailTel's representative and charges for 3<sup>rd</sup> party inspection, if any, shall be borne by RailTel but necessary facilities to carry out tests / witness inspection shall be provided by the manufacturer, free of cost.

25.2 Along with inspection call, the supplier / manufacturer shall submit details of test procedures, test programme, test parameters together with permitted values, etc. and their Quality Assurance Plan.

25.3 In case material fails during inspection, the same shall be replaced, free of cost, by manufacturer/supplier. In such a case, total cost of re-inspection including travel, lodging & boarding of the inspecting officials shall be to manufacturer's/supplier's account.

Nominated RailTel Engineer will issue inspection certificate of successfully completion of the test/inspection.

## **26. Force Majeure**

Force majeure shall mean -

- War, hostilities (whether war be declared or not), invasion, act of foreign enemies.
- Rebellion, revolution, insurrection or military or usurped power, or civil war.
- Ionizing radiation, or contamination by radio-activity from any nuclear fuel, or from any nuclear waste from the combustion of nuclear fuel, radio active toxic explosive or other hazardous properties of any explosive nuclear assembly or nuclear component thereof.
- Presume waves caused by aircraft or other aerial devices traveling at sonic or supersonic speeds.

- Riot, commotion or disorder, unless solely restricted to employees of the Contractor or of his Subcontractors and arising from the conduct of the works.
- Loss or damage due to the use or occupation by the Employer of any section or part of the permanent works, except as may be provided for in the contract.
- Loss or damage due to the extent that it is due to the design of the works, other than any part of the design provided by the contractor or for which the contractor is responsible, and
- Any operation of the forces of nature against which an experienced contractor could not reasonably have been expected to take precautions.

**27. Settlement of Disputes**

In case of any dispute concerning this order both the supplier and RailTel shall try to settle the same amicably through mutual discussion/negotiations. Any unsettled dispute shall be settled in terms of Indian Act of Arbitration and conciliation 1996 or any amendment thereof. Place of arbitration shall be New Delhi. Arbitrator shall be appointed by Chairman & Managing Director, RailTel Corporation of India Limited.

**28. Governing Laws**

This contract shall be interpreted in accordance with the laws of India. The courts at New Delhi shall have exclusive jurisdiction to entertain and try all matters arising out of this contract.

**29. Termination for Default**

**29.1** The purchaser may without prejudice to any other remedy for breach of contract, by written notice of default, sent to the supplier, terminate this contract in whole or in part.

- a. If the supplier fails to deliver any or all of the goods within the time period(s) specified in the contract.
- b. If the supplier fails to perform any other obligation(s) under the contract; and
- c. If the supplier, in either of the above circumstance(s) does not remedy his failure within a period of 30 days (or such longer period as the Purchaser may authorize in writing) after receipt of the default notice form the purchaser.

**29.2** In the event the purchaser terminates the contract in whole or in part, due to nonperformance of the contractor, the Purchaser may proceed, to procure upon such terms and in such manner, as it deems appropriate, goods similar to those undelivered and in such case the PBG shall be forfeited.

**30. Termination for Insolvency**

The purchaser may at any time terminate the order/contract by giving written notice to the supplier, without compensation to the supplier, if the supplier becomes bankrupt or otherwise insolvent as declared by the competent court provided that such termination will not prejudice or affect to the Purchaser.

32.2 Earnest Money Deposit (EMD) equal to **Rs. 1,39,990** (Rupees One Lakh Thirty Nine Thousand **Nine** Hundred and Ninety Only) in the form of Account Payee Bank Draft in favour of RailTel Corporation of India Limited, payable at New Delhi, should be enclosed with the tender bid. ### **33. UNIT PRICES**

33.1 The prices quoted by the Tenderer shall include the prices of materials including all incidental charges for transport, loading/ unloading and handling of materials, commission for arranging dispatch by rail direct from manufacturer's factory and completing all necessary formalities in this respect, such as submission of forwarding notes, arranging placement of Wagon, collection of banker's charges for Bank guarantee, Indemnity Bonds inclusive of cost of Stamp etc. as also siding or shunting charges, if any, levied by the Railway.

33.2 The prices shall include all taxes , duties, Royalty, GST and levies (including GST etc.) applicable on this Supply Contract. Therefore, they should quote their prices taking into account all types of taxes including GST on supply contract as leviable. Ambiguous charges without firm and specific figures quoted as “extra” will make the bid liable to be **summarily rejected.**

33.3 The prices quoted by the tenderer shall include all cost of Administration of Contract, Insurance Premium, Banker's charges for guarantees, cost of storage, loading-unloading and handling of materials and for any road transport which the contractor may use for carriage of materials to his depot and the site of work. The prices shall include the cost of works and adjustments necessary to be done by the contractor during or after tests carried out by the purchaser.

- 33.5 While the price quoted in the contract are inclusive of all taxes i.e. GST levied by any statutory authority, the purchaser shall make any deduction toward GST on supply contract if statutorily required to do so. The deducted GST on supply contract shall be remitted to the concerned GST authority and the purchaser shall in no way be responsible for any disputes between the GST authorities and the contractor in this regard.
- 33.6 All taxes, duties and levies (Including GST) arising out of the transaction between the contractor and his sub contractor/supplier for this work will be included in the rates quoted by the contractor in the relevant Schedule.
- 33.7 No import license shall be arranged by the RailTel for this work.
- 33.8 The price quoted in the offer should be firm, fixed indicated the breakup and inclusive of all taxes & duties like import, custom, CGST, SGST, IGST, UTGST etc. The offer should be inclusive of packing, forwarding, freight up to destination, insurance charges.
- 33.9 Bidder shall issue valid tax invoice to RailTel for availing proper credit of CGST/SGST/IGST/UTGST incase of award of contract. GST will not be reimbursed in the absence of valid tax invoice.
- 33.10 For all the taxable supplies made by the vendor, the vendor shall furnish all the details of such taxable supplies in the relevant returns to be filed under GST Act.
- 33.11 If the vendor fails to comply with any of the above, the vendor shall pay to purchaser any expense, interest, penalty as applicable under the GST Act.
- 33.12 In case of incorrect reporting of the supply made by the vendor in the relevant return, leading to disallowance of input credit to purchaser, the vendor shall be liable to pay applicable interest under the GST Act to the Credit of purchaser. The same provisions shall be applicable in case of debit/credit notes.
- 33.13 Tenderer shall quote all inclusive rates, but there shall be break up of basic price and all type of applicable taxes such as SGST/CGST/IGST/UT GST along with respective HSN/SAC Code under GST Law (including tax under reverse charges payable by the recipient).
- 33.14 Wherever the law makes it statutory for the Purchaser to deduct any amount towards GST at sources, the same will be deducted and remitted to the concerned authority.
