1. **Chapter 4, Technical specifications- Under Page No. 24, and heading “Integration of the device with the existing TPaaS infrastructure at RailTel”, point V may be read as:**

The Telepresence unit must get integrated with existing TPaaS management platform of CISCO for Software updates/upgrades, provisioning, configuration, backup and restore.

Or

The offered Video conferencing endpoints have to be interoperable with existing Video Communication Server for TPaaS.


