(RailTel), Eastern Region on behalf of East Central Railway invites Open e- Bids in single packet single stage system from established contractors with proven experience for the work of "Excavation of open trench/HDD, Laying of HDPE Duct and Quad/ PIJF cable Backfilling, blowing/pulling, splicing, termination and testing of OFC cable and termination of Quad / PIJF cable with other associated work in Sakri -Biraul section of East Central Railway".
