2. Scope of EOI

The Scope of EOI is to select a suitable firm out of RailTel Empaneled Partners for providing OEL & OVM Support and associated services to RCIL Customer.

3. Scope of Work:

3.1. Item No. 1 (Oracle Linux Premier Limited Support Subscription in RCIL DC) : Procurement of Oracle Linux Premier Limited subscription and to provide support at RCIL DC.

3.2. Item No. 2 (Oracle VM Premier Limited Support Subscription in RCIL DC) : Procurement of Oracle VM Premier Limited subscription and to provide support at RCIL DC.

3.3. Item No. 3 (Sysadmin IT Resource Level 3 Support for OEL and OVM) :

3.3.1. Dedicated Resource shall be Responsible for the maintenance, configuration, and reliable operation of hardware, OS and virtualization'

3.3.2. Working with Oracle support on patch upgrade for OEL and OVM

3.3.3. Virtualization maintenance and dashboard setup, resource allocation and monitoring

5. Payment Terms

- 12.1 For Item No.1 & 2 of SOR : Annual Advance Payment shall be released to firm only after receiving first payment from RCIL Customer.
- 12.2 For Item No.3 & 4 of SOR : Payment will be on monthly basis after receipt of satisfactory services and receiving the tax invoice from selected partner. The Payment shall be released respectively after receiving each quarterly payment from RCIL Customer.

7. Contract Duration

The contract shall be initially valid for the period of 3 years from the date of issue of Purchase Order/LOA. However, contract can be extended further or terminated as per Customer requirement and as per approval from RCIL competent authority.

8. SLA's

The service level arrangement will be back to back and the entire penalty deducted by Customer will be passed on to selected bidder. R

9. REL's Right to Accept/Reject Bids

REL reserves the right to accept or reject any bid and annul the bidding process or even reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or without any obligation to inform the affected bidder or bidders about the grounds for RailTel's action.

10. Bidding Document

The bidder is expected to examine all instructions, forms, terms and conditions and technical specifications in the bidding documents. Submission of bids, not substantially responsive to the bidding document in every aspect will be at the bidder's risk and may result in rejection of its bid without any further reference to the bidder.

All pages of the documents shall be signed in ink by the bidder including the closing page in token of his having studied the tender document.

11. Period of Validity of bids and Bid Currency

Bids shall remain valid for a period of 180 days from the date of opening of the bids RCIL shall at its own discretion reject a bid value for shorter period. The prices in the bid document shall be expressed in Indian Rupees only.

12. Security Deposit / Performance Bank Guarantee (PBG)

In case if RCIL Customer demands PBG from RCIL then the successful bidder shall have to submit a performance Bank Guarantee (PBG) within 30 days of the issue of Purchase order @ 10% of the value of the PO for the satisfactory performance of materials covered in SOR given under Clause No.-5 and valid for a period of 4 months beyond contract period. Extension of time for submission of BG beyond 30(thirty) days and up to 60 days from the date of issue of Letter of acceptance may be given by the Eligible Bidder Authority. However, a penal interest of 15% per annum shall be charged for delay beyond 30(thirty) days. i.e from 31st day after issue of LOA. In case the contractor fails to submit the requisite PG even after 60 days from the date of issue of LOA, the contract shall be terminated duly forfeiting EMD and other dues, if any, payable against that contract. The failed contractor shall be debarred from participating in re-tender for that work.

- 13.1 The earnest money shall be released on submission of PBG. The Performa for PBG is given under Form No. 1. If the delivery period gets extended, the PBG should also be extended

appropriately.

- 13.2 This PBG would be released after satisfactory completion of contract.
- 13.3 No interest shall be paid on the amount of earnest money and Performance Security held by the RailTel, at any stage.
- 13.4 Any performance security upto value of Rs. 5 Lakh is to be submitted through online transfer only.

13. Bid Earnest Money (EMD)

- 13.5 The tenderer shall furnish a sum as given in EOI Notice as Earnest Money in the form of Demand Draft from any scheduled bank in India in favour of “RailTel Corporation of India Limited” payable at Delhi which should remain valid for at least 45 days beyond the bid opening date.
- 13.6 The EMD may be forfeited if a bidder withdraws his offer or modifies the terms and conditions of the offer during validity period and in the case of a successful bidder, if the bidder fails to accept the Letter of Acceptance (LOA) and fails to furnish performance bank guarantee (security deposit) in accordance with clause 12.
- 13.7 Offers not accompanied with valid Earnest Money shall be summarily rejected.
- 13.8 Earnest Money of the unsuccessful bidder will be discharged / returned as promptly as possible but not later than 30 days after the expiry of the period of offer / bid validity prescribed by the Purchaser.
- 13.9 The successful bidder's EMD will be submitted as Security Deposit on issue of Purchase Order.
- 13.10 Earnest Money will bear no interest.

13.11 For Micro and Small Enterprises (MSEs)

- 13.11.1 Certain benefits/preferential treatment shall be extended to the registered MSEs as per guidelines issued in the latest notification of Ministry of MSME/ Government of India.
- 13.11.2 MSEs who are interested in availing themselves of these benefits will enclose with their offer the proof of their being MSE registered with any of the agencies mentioned in the notification of Ministry of MSME.
- 13.11.3 The MSMEs must also indicate the terminal validity date of their registration.
- 13.11.4 Failing 13.10.1 and 13.10.2 above, such offers will not be liable for consideration of benefits detailed in the notification of Government of India.

14. Bidding Process (Single Packet System)

The bidding process will consist of single packet system. The detailed technical proposal i.e. the including 'Price Bid' shall be submitted in sealed envelope.

15. Deadline for Submission of Bids

Bids must be submitted to RCIL at the address specified in the preamble not later than the specified date and time mentioned in the preamble. If the specified date of submission of bids being declared a holiday for RCIL, the bids will be received up to the specified time in the next working day.

16. Late Bids

Any bid received by RCIL after the deadline for submission of bids will be rejected and/or returned unopened to the bidder.

17. Modification and/or Withdrawal of Bids

Bids once submitted will be treated, as final and no modification will be permitted. No correspondence in this regard will be entertained.

No bidder shall be allowed to withdraw the bid after the deadline for submission of bids.

In case of the successful bidder, he will not be allowed to withdraw or back out from the bid commitments. The bid earnest money in such eventuality shall be forfeited and all interests/claims of such bidder shall be deemed as foreclosed. No interest will be paid on EMD amount

18. Details of Financial bid

- a. The financial bid should clearly bring out the cost of the work with detailed break-up of taxes.
- b. The financial bid must be submitted as per the enclosed Proforma in Tender document.

19. Clarification of Bids

To assist in the examination, evaluation and comparison of bids the purchaser may, at its discretion, ask the bidder for clarification. The response should be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.

20. Variation in Contract:

+/- 25 % variation may be operated during the period of validity of agreement with the approval of competent authority with similar terms and procedure as specified in the agreement.

21. Bid evaluation Process

Evaluation will be done on lowest offer quoted by the bidder (under Total amount i.e. SOR (A) plus SOR(B) in Clause Number – 6 **SOR** (Schedules of Rates) for providing IT services.

24. Other Terms and Condition

1. Bidders are requested to quote their best prices considering the fact that price negotiation, if required with the vendor will be passed on to the selected bidder.
2. Unless otherwise specified all prices quoted must remain firm except for statutory variation in taxes and duties during contractual delivery period. Any increase in taxes and duties after expiry of the delivery period will be to vendor account.
3. Quotations should preferably be typewritten and any correction or over- writing should be initialed. Rates to be indicated both in words and figures.
4. Sealed quotations in envelope superscribing tender enquiry number and due date of opening must be sent by Registered or Speed Post or to be dropped in the Tender Box specified for the purpose. Quotations received after specified date and time are liable to be rejected.
5. Quotation should be valid for a minimum period of 180 days from the date of opening of tender.

6. Printed conditions on the back side of the offers will be ignored.
7. If the tenderer is unable to quote against the Enquiry, Regret letter must be sent. Failure to do so repeatedly may result in deletion of tenderer's name from the approved list of BA/SI.
8. Any increase in taxes and duties after expiry of the delivery period will be to supplier's account. This will be without prejudice to the rights of RCIL for any other action including termination.
9. RCIL shall have the right to terminate the contract by giving 30 days notice without assigning any reasons thereof. However, in the event of any breach of terms of the contract, RCIL will have right to terminate the contract by written notice to the Seller.
10. FORCE MAJEURE: Any delay or failure to perform the contract by either party caused by acts of God or acts of Government or any direction or restriction imposed by Government of India which may affect the contract or the public enemy or contingencies like strikes, riots etc. shall not be considered as default for the performance of the contract or give rise to any claim for damage. Within 7 days of occurrence and cessation of the event(s), the other party shall be notified. Only those events of force majeure which impedes the execution of the contract at the time of its occurrence shall be taken into cognizance.
11. In case of any dispute or difference arising out of the contract which can not be resolved mutually between RCIL and vendor, it shall be referred to a Sole Arbitrator to be appointed by the CMD, RCIL.
12. The Arbitration and Conciliation Act, 1996 and rules made there under shall apply to the Arbitration Proceedings.
13. The contract shall be governed by and construed according to the laws in force in India and subject to exclusive jurisdiction of the Courts of Delhi only.
