(RailTel), Eastern Region invites Open e- Bids in single stage two packet system from established contractors with proven experience for the work of "Supply, laying, jointing & termination of OFC cable and Power cable including execution of allied work for creation of LAN & Switch network Wi-Fi service in Alipurduar Jn. (APDJ) & New Alipurduar (NOQ) Railway stations".
