Any interests received after the stipulated time period or not in accordance with the specified format will be summarily rejected. Delivery of the responses along with documents against the interests will be the sole responsibility of the responding bidder.

The bidder shall replicate the best recruitment and other Human Resource Management practices prevailing in Govt/PSUs/Reputed organizations.

5.0 SUBMISSION OF PROPOSAL

The proposals duly signed on every page, serial numbered, including annexure/appendices shall be submitted in sealed envelopes. The envelopes shall be sealed in an outer envelope bearing the address, Executive Director/RGM/SR, RailTel Corporation of India Ltd., (A Govt. of India Enterprise), :2nd Floor, B-Block, Railnilayam, Secunderabad, Telangana 500071.

The envelope/packet shall be clearly marked as under:

- Chennai Circle Technical (Engineering-Project, Operation & Maintenance) Category.

The proposal should be signed by a duly authorized representative of the bidder. It shall be certified that the person signing the proposal is empowered to do so on behalf of the Company. A copy of the Memorandum and Articles of Association of Company shall be attached to the proposal, along with other relevant documents.

The person signing the proposal or any documents forming part of the proposal on behalf of another or on behalf of a firm shall be responsible to produce a power of attorney duly executed in his favour, stating that he has the authority to bind such other person or the firm as the case may be, in all matters pertaining to the contract. If the person so signing the proposal fails to produce the said power of attorney, his proposal shall be liable for summarily rejection without prejudice to any other right of RailTel under the law.

The proposal shall be filled in by the bidder neatly and accurately. Any overwriting/correction without authentication will be liable for summarily rejection without prejudice to any other right of RailTel.

Conditional offers/offers which are not in conformity to the prescribed document will be summ arily rejected. All the documents submitted with the proposal are to be furnished duly signed on all pages.

RailTel does not guarantee any definite volume of work or any particular service at any time or throughout the period of contract to any specific empanelled vendor.

However, in case of any variations during the currency of the contract, the SD would need to be enhanced as per the terms-over the entire contract value and shall be applicable once the value exceeds 25% of the original contract value. The Manpower Requirement (including the existing men on roll) will be Allotted among the empanelled agencies at the sole discretion of the RailTel Corporation of India Limited.

The contract agreement with the bidder for delivery of the services through deployed sources shall be for **One Year** which may be further extended or short closed based on RailTel's requirement and performance of the manpower bidder agency. The decision for granting extension or short closure shall be the sole discretion of RailTel Corporation which shall be final and binding on the bidders.

The emoluments to be paid to deployed resources by the bidder are fixed by RailTel itself. The emoluments so fixed are always kept above the Minimum wages prescribed by Ministry of Labour and employment, O/O Chief Labor Commissioner.

In case, the bidder wishes to provide any insurance coverage or any other social security benefits to its personnel, the same shall be borne by the bidder and shall be reimbursed separately.

6.0 SECURITY DEPOSIT: The successful contracting bidder will have to deposit 5% of value of the contract as **Security Deposit**, through Bank Guarantee, Demand Draft or Banker's cheque in favor of "RailTel Corporation of India Limited" for due fulfillment of the contractual obligations which is refundable without any interest thereon on successful completion of the contract after deducting, if required, any pecuniary loss arising out of non- compliance of any of the statutory provision, labor and other laws.

The Security Deposit amounting to 5 % of contract value shall be submitted within 30 days from the date of issue of LOA. Extension of time for submission of SD beyond 30 days and up to 60 days from the date of issue of LOA may be granted subject to the condition that a penal interest of 15 % per annum of the amount of BG shall be charged for the period of delay beyond 30 days i.e. 31 st day after date of issue of LOA. However, Railtel reserve the right to terminate the contract in case the bidder fails to submit the requisite SD within 60 days. In case the successful bidder is not able to submit BG, the bidder will have options to submit this amount in the form of Demand draft. The SD amount shall be released after satisfactory completion of the work and on expiry of warranty.

A separate advice of the BG will invariably by sent by the BG issuing bank to the RailTel Bank through SFMS and only after this the BG will become acceptable to RailTel. It is therefore in own interest of Bidder to obtain RailTel bank IFSC code, its branch and address and advice these particulars to the BG issuing bank and request them to send advice of BG through SFMS to the Railtel's Bank.

The successful bidder/s shall be required to sign an agreement (Annexure-II) with the representative of RailTel for carrying out the work according to the tender documents within 15 days after the receipt of notice from RailTel that such documents are ready.

7.0 EVALUATION CRITERIA

Empanelment will be based on aggregate of marks assigned to the agency with reference to criteria, as indicated in **Annexure-1a**, **1b**, **1c**, **1d & 1e**of this Expression of Interest (EOI) document for respective EOI categories. Agencies (One or more) will be empanelled as per marks obtained.

If similar marks are obtained by more than one bidder then the decision rests with RailTel on which of them or all have to be empanelled duly considering various factors including their selection for the other bids.

These bids will be opened in presence of authorized representative of the firm's bidder.

7.1 Similar nature with regard to the bid is defined as under:

A) Non-Technical Categories:

- I. Personal Assistant/Office Assistant: Secretarial services, shorthand and outdoor/liaison and other activities as and when directed. File document/Record management and maintenance. Maintenance of stationery and other activities as and when directed.

- I. Network Engineering IT related jobs, Network Trouble shooting, Assisting Technical Executives in Network issues, Marketing the products of the company and audit & Compliances, reconciliation, Accounts Maintenance etc. in respective Circles of operation
- C) Technical Categories: Technical (Engineering Project, Operation & Maintenance)
 Category Secunderabad/Chennai Circle
- I. Technical Engineering- Project, Operation & Maintenance. Graduate Engineer/Diploma Engineer/Technicians: Maintenance OFC Network Projects and Service delivery related activities in respective Circles of operation

In case any of the bidders furnishes a composite contract in support of this requirement, then, there should be a clear bifurcation of the requisite parameters in terms of technical and non-technical Categories separately.

The bidder should provide the details of the organizations/firms to which they have supplied similar manpower in the stated 3 financial years (2016-17, 2017-18 and 2018-19) in the following format with supporting documents:

The Bidder should unconditionally accept the terms and conditions contained in this EOI.

The Offer so made by the bidder, shall remain valid for a minimum period of 30 days from the last date of bid opening.

7.2 Verification of Credentials:

The certificate from the actual user about the satisfactory performance indicating all the details as given herein shall be enclosed with the tender.

The bidder shall submit documents in support of his/her/their claim to fulfill the eligibility criteria as mentioned in the tender document clearly relating the specific eligibility criterion and the specific document(s) submitted in support thereof.

Each page of the copy of documents/certificates in support of credentials, submitted by the bidder, shall be self-attested by the bidder or authorized representative of the tendering firm. Self-attestation shall include signature, stamp and date (on each page).

"The bidders shall submit a notarized affidavit on a non-judicial stamp paper of Rs.100 stating that they are not liable to be disqualified and all their statements/documents submitted along with Bid are true and factual. Standard format of the affidavit to be submitted by the Bidder is enclosed as Form-III. Non submission of an affidavit by the Bidder shall result in summarily rejection of his/their Bid. And it shall be mandatorily incumbent upon the bidder to identify state and submit the supporting documents duly self-attested by which they/he is qualifying the Qualifying Criteria mentioned in the Tender Document. It will not be obligatory on the part of the RailTel to scrutinize beyond the submitted document of bidder as far as qualification for the tender is concerned."

RailTel reserves the right to verify all statements, information and documents submitted by the Bidder in his tender offer, and the Bidder shall, when so required by the RailTel, make available all such information, evidence and documents and may be necessary for such verification. Any such verification or lack of such verification, by the RailTel does not relieve the Bidder of its obligations or liabilities here under nor will it affect any rights of the RailTel there under.

In case of any wrong information submitted by the bidder, Security Deposit (SD) of contract shall be forfeited and agency shall be barred for doing business on entire RailTel for 5 (five) years.

7.3 NSIC registered Firm and micro and small enterprises (MSEs)

For NSIC registered firm and micro and small enterprises (MSEs) that are having valid Udyog Adhar Memorandum and for small scale units and micro units registered with NSIC under single point registration Scheme and participating in this tender enquiry, following exemptions are available:-

- (i) They shall be exempted from cost of tender documents.
- (ii) They shall also be exempted from depositing Earnest money. These exemptions shall be applicable provided units are registered with NSIC/MSEs for tendered item and registration is current and valid. Firms claiming these exemptions are required to submit along with their offer, a copy of their current and valid NSIC registration certificate for the tendered item/items, otherwise their offer would not be considered.
- (iii) No exemption is, however, applicable to these units from payment of security deposit.

8.0 EARNEST MONEY DEPOSIT (EMD)

The EMD of unsuccessful participant will be refunded without interest after validity period. The EMD of the selected Bidder will be adjusted against the Security Deposit.

- (a) The EOI shall hold the offer open till its validity. It being understood that the EOI documents have been issued to the bidders and the bidders has been permitted to EOI in consideration of stipulation on his part, that after submitting his EOI he will not change his offer or modify the terms and conditions thereof in a manner not acceptable to RailTel. If the bidders fails to observe or comply with the foregoing stipulation the aforesaid amount deposited as earnest money shall be liable to be forfeited by the RailTel.
- (b) If the EOI is accepted, then, this earnest money mentioned in sub clause (a) above can be retained as part security for the due and faithful fulfillment of the contract with balance being paid through BG towards SD or In case a valid BG (Total amount) towards SD is submitted, then, the EMD can be released. The Earnest Money of other bidders shall, save as herein before provided, be returned to them, but RailTel shall not be responsible for any loss or depreciation that may happen thereto while in their possession, nor be liable to pay interest thereon.

The earnest money should in any of the following forms.

Demand drafts: These forms of earnest money could be of any of the nationalized banks. No confirmatory advice from the Reserve Bank of India will be necessary.

Demand Drafts shall be drawn in favour of RailTel Corporation of India Limited, payable at Secunderabad and endorsed "Account Payee".

Online Payment of EMD: RailTel Account No 327301010373007 in Union Bank Of India, Secunderabad IFSC code UBIN0532738 (UTR No to be mentioned in EOI)

The bid guarantee / earnest money may be forfeited, if a bidder withdraws its EOI during the period of EOI validity and in the case of successful bidder, if the bidder fails to Sign the contract along with necessary Bank Guarantees in stipulated time.

The Earnest Money of unsuccessful bidders will save as herein before provided, be returned within reasonable time to the unsuccessful bidders but the RailTel shall not be responsible for any loss or depreciation that may happen to the security for the due performance of the above stipulation to keep offer open for the period specified in the EOI documents or to the Earnest Money while in their possession nor be liable to pay interest thereon.

Expression of Interest not accompanied by Earnest Money will be summarily rejected unless exempted

9.0 SERVICE CHARGES

The service charges payable to the successful bidder(s) will be @ 5% of the remuneration payable to the personnel deployed.

10.0 AWARD OF CONTACT

The contract shall be awarded to the Bidder, by conveying acceptance of the proposal by RailTel through registered /speed post/ courier.

All the terms and conditions as stated in the proposal documents, appendices and acceptance conveyed by RailTel will constitute the contract between the bidder and RailTel.

The selected bidder(s) is/are expected to commence the assignment on the date work order to be issued by RailTel as per its requirement & on the terms & conditions specified.

The empanelled agencies shall be distributed the manpower as given by RailTel at short notice.

11.0 FORCE MAJEURE

For the purposes of this Contract, "Force majeure" means any unforeseen event directly interfering with the services during the currency of the contract such as war, insurrection, restraint imposed by the government, act of legislature or other authority, explosion, accident, strike, riot, lockout, act of public enemy, act of God, sabotage which is beyond the reasonable control of a party and which makes a Party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.

The obligations of RailTel and the Bidder shall remain suspended if and to the extent that they are unable to carry out such obligations owing to force majeure or reasons beyond their control.

The failure of a party (RailTel or the bidder) to fulfill any of its obligations under the contract shall not be considered to be a breach of, or default under, this Contract insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event:-

- (a) Has taken all reasonable precautions, due care and reasonable alternative measures in order to carry out the terms and conditions of this Contract, and
- (b) Has informed the other party as soon as possible about the occurrence of such an event and such impossibility subsists for not less than 60days.

Any period within which a party shall, pursuant to this contract, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.

The bidder is entitled to the payments for the portion of the work already completed before the happening of any event constituting Force Majeure culminating in termination of contract. Decision of RailTel in this regard will be final.

12.0 INDEMNITY

The Bidder hereby agrees to keep indemnified and shall keep indemnified and hold harmless, RailTel and its Directors, officers and employees from and against all and any claims, demands etc.

That the Bidder on its part and through itsown resources shall ensure that they are not damaged in the process of carrying out the services undertaken by its employees and shall be responsible for acts of commission and omission on the part of its staff and its employees etc. If this office suffers any loss or damage on account of negligence, default or theft on the part of the employees/agents of the bidder, then the bidder shall be liable to reimburse this office for the same. The bidder shall keep this office fully indemnified against any such loss or damage. For any accident/ casualty occurred during the course of working to any staff engaged by the bidder, the responsibility will remain with the bidder. For any accident or casualty occurred during the course of working to any staff deployed by the bidder, the liability that will arise out of the accident/incident will be borne by the bidder and this office will in no way be responsible for it or any other clause mentioned above.

13.0 OTHER TERMS & CONDITIONS

Any changes in the terms of the document can only be made in writing and by mutual agreement. This contract, its meaning and interpretation, and the relation between the parties shall be governed by the laws of India for the time being in force.

Any notice, request, or consent made pursuant to this contract shall be in writing and shall be deemed to have been made when delivered in person or sent by registered/speed post/courier to an authorized representative of the Party.

The Services shall be performed at such locations as specified by RailTel from time to time.

Any action required or permitted to be taken, and any document required or permitted to be executed, under this contract by RailTel or the bidder, may be taken or executed by the officials authorized.

Unless otherwise specified, the Bidder and their deployed personnel shall pay such taxes, duties, fees etc. as may be levied under Central/State Law and same will not be reimbursed by RailTel.

RailTel reserves the right to modify, expand, restrict, scrap and re-float the EOI without assigning any reasons.

Bidders with proven track records in their areas may send their responses along with required documents to qualify themselves as detailed in pre-qualification criteria within the stipulated time frame.

Bidders have to provide appointment letter, photo Identity cards, ESI cards, pay slip of each month to the manpower supplied to RailTel on hired basis, employed by him/her for carrying out the work of RailTel. Bidders will ensure for the same before the supply of manpower to RailTel.

The remuneration payable to all outsourced staff deployed by bidders will be decided by RailTel Corporation and bidders shall pay the monthly salary/allowances etc. if any as advised by RailTel Corporation of India Ltd. Salary/allowances if any are to be disbursed by bidders strictly as per the directives of RailTel Corporation.

The allowance/arrear if any may be of past period has to be disbursed by bidders as directive by RailTel. The PF/ESI contributions in respect of both employee and Employer's contributions also will be decided by RailTel Corporation.

14.0 COMMENCEMENT, COMPLETION, MODIFICATION, AND TERMINATION OF CONTRACT – EFFECTIVENESS OF CONTRACT

14.1 Commencement of Services

This Contract shall come into effect from the date of issuance of letter of intent by RailTel. The selected bidder is expected to commence the assignment on the date and at the location to be specified in the work order to be issued by RailTel as per its requirement. If the Bidder fails to commence the assignment within the specified schedule as per work order, the contract shall be liable to be terminated.

14.2 Expiration of Contract

Unless terminated earlier, the contract shall expire at the end of such time period after the effective date.

14.3 Modification

After award of the contract, any minor changes in the modus of implementation can be agreed to, mutually in writing.

14.4 Subletting

The Bidder shall not sublet, transfer or assign the contract or any part thereof to other party in the normal course. However, in case of specific requirement to on-board anyone from the payrolls of other agencies, then express written consent needs to be obtained from RailTel. In the event of the

Bidder contravening this condition, RailTel shall be entitled to terminate the engagement to the extent of any or full portion of the contract duly forfeiting the requisite SD.

14.4 TERMINATION

1) By Corporation(RailTel)

RailTel may terminate the contract, by giving 7 (seven) days written notice of termination to the bidder, to be given after the occurrence of any of the events specified below except (d). And sixty (60) days in the case of the event referred to in clause(d).

- (a) If the bidder commits breach of any condition of the contract or do not remedy/rectify a failure in the performance of their obligations under the contract.
- (b) If the bidder becomes insolvent and bankrupt.
- (c) If as the result of Force Majeure, the bidders are unable to perform a material portion of the Services for a period not less than sixty (60) days; or
- (d) If RailTel, in its sole discretion, decides to terminate this Contract.
- (e) If the bidder or its employees/agents indulges in any malpractice relating to providing the outsourcing of the services.
- Monpayment of statutory dues to the concerned department.

In the event of termination on unsatisfactory service or in violation of any of the terms & conditions of contract, SD (Security Deposit) shall stand forfeited in addition to banning of bidder for a period of 2 years. This will be in addition to any other action that RailTel may deem fit in the facts and circumstances of the case.

In case of nonpayment of statutory dues by the bidder, RailTel will recover the payment of taxes already made to the bidder along with Interest and penalties or any other charges imposed on RailTel due to the default of bidder.

2) By Bidder

The Bidder may terminate this Contract, by not less than Sixty (60) days written notice to RailTel if it fails to pay any undisputed amount due to the Bidder under the Contract, provided that if RailTel pays such amount within notice period such termination notice shall become in fructuous.

14.5 PAYMENT UPON TERMINATION

RailTel at its sole discretion may decide & pay remuneration for services satisfactorily performed prior to the effective date of termination provided such termination is not on account of any breach of contract by the bidder.

15.0 OBLIGATIONS OF THE BIDDER

The bidder shall perform the services and carry out their obligations with all due diligence, efficiency and economy in accordance with generally accepted professional techniques and practices, and shall observe sound management practices, and employ appropriate technology and safe methods. The bidder shall always act, in respect of any matter relating to this Contract or to the services, as faithful advisers to RailTel, and shall at all times support and safeguard RailTel's legitimate interests in dealings with the third parties.

15.1 Statutory Compliances & Labour Laws:

Compliance of labor laws, Payment of Minimum Wages Act, workman's Compensation Act, EPF/ESI provisions, Shramikkalyan provisions and any such statutory provisions viz-a viz the employee would be the responsibility of the bidder/contractor and the Contractor shall submit a certificate of the compliance thereof to RailTel. The invoice for a particular month must be accompanied by the documentary proof towards the above for the previous month.

15.2 Mandatory Aadhar Card Holder for employment

In employment of manpower to be deployed for the delivery of services with RailTel, it is compulsory for manpower (candidates/employees) to have Aadhar Card/Number. And payments to be made to these deployed manpower, through Aadhar linked Bank transfer only.

15.3 Special Conditions of contract for mandatory updating of labour data on Railway's shramik- kalyam portal by contractor.

In order to increase transparency in payment of contract Labour wages and other payments, a web based e-application has been developed and hosted on website www.shramikkalyan.indianrailways.gov.in.

All contractors are required to upload details of their LOA's engaged workmen, wage payment details, PF/ESI details, bonus details, on monthly basis. The details so uploaded shall be available in public domain.

- A. Contractor is to abide by the provisions of payment of wages act & Minimum wages act. In order to ensure the same, an application has been developed and hosted on websitewww.shramikkalyan.indianrailways.gov.in. Contractor shall register his firm/company etc. and upload requisite details of labour and their payment in this portal. These details shall be available in public domain. The Registration /updating of portal shall be done asunder:
 - Contractor shall apply for one time registration of his company/Firm etc. in the Sharmikkalyan
 portal with requisite details subsequent to issue of letter of Acceptance. P&A Department/
 RailTel shall approve the contractor's registration on the portal within 7 days of receipt of such
 request.
 - 2 Contractor once approved by RailTel-P&A Department, can create password with login ID (PAN No.)for subsequent use of portal for all LOAs issued in his favour.
 - 3. The contractor once registered on the portal, shall provide details on his letter of Acceptances (LOA)/Contract Agreements on shramikkalyan portal within 15 days of date of issue of any LOA for approval of concerned P&A department. P&A department/ RailTel shall update (if required)and approve the details of LOA filled by contactor within 7 days of receipt of such request.
 - 4. After approval of LOA by P&A department of RailTel, contractor shall fill the salient details of contract labours engaged in the contract and ensure updating of each wage payment to them on shramikkalyan portal on monthly basis.
 - 5. It shall be mandatory upon the contractor to ensure correct and prompt uploading of all salient

details of engaged contractual labour& payments made thereof after each wage period.

B. While processing payment of any 'On Account bill' or Final bill or release of 'Advances' or Security deposit, contractor shall submit a certificate to the P&A department/ RailTel that I have uploaded the correct details of contract labours engaged in connection with this contract and payment made to them during the wage period in Railway's Shramikkalyan portal at 'www.shramikkalyan.indianrailways.gov.in' till month/year.

16.0 THE BIDDER NOT TO BENEFIT FROM COMMISSIONS, DISCOUNTS, RECRUITMENT FEES.

The bidder shall not accept for their own benefit any trade commission, discount, or similar payment or any other benefits in connection with the activities under the Contract, and the bidder shall use their best efforts to ensure that their deployed personnel's or agents too shall not receive any such payment/benefit.

Neither the bidder nor their deployed personnel shall engage, either directly or indirectly, in any such activities which conflicts with their role under the assignment.

All transactions between the bidder and third parties shall be carried out as between two principals without reference in any event to RailTel. The bidder shall also undertake to make the third parties fully aware of the position aforesaid.

Bidder shall be liable to pay damages to RailTel for any losses, costs and expenses including litigation expenses incurred by RailTel due to breach of any of the terms and conditions of this contract and failure to perform any of the obligations under the contract.

The bidder shall give detailed descriptions of the services to be performed, period for completion of various tasks, different tasks, specific tasks, etc. to be approved by RailTel.

17.0 CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

Each party shall not without prior written consent of the other party at any time divulge or disclose to any person or use for any purpose unconnected with the implementation of the project, any information concerning the project, the services, proprietary material except to their respective officers, directors, employers, agents, representatives and professional advisors on a need to know basis or as may be required by any law, rule, regulation or any judicial process.

This Clause shall not apply to information:

- 1) Already in public domain, otherwise than by breach of this agreement.
- Already in the possession of the receiving party before it was received from the other party in connection with this agreement and which was not obtained under any obligation of confidentiality.
- 3) Obtained from a third person who is free to divulge the same and which was not obtained under any obligation of confidentiality.

18.0 THE BIDDER SHALL OBTAIN RAILTEL'S PRIOR APPROVAL IN WRITING WHEREVER NECESSARY.

Documents prepared by the bidder and their deployed personnel are to be the property of the RailTel. All plans, charts, specifications, designs, reports, and other documents and software submitted by the bidder shall become and remain the property of RailTel, and the bidder shall, not later than upon termination or expiration of the contract, deliver all such documents and software to RailTel, together with a detailed inventory thereof. The Bidder may retain a copy of such documents and software provided the future use of these documents, if any, shall be subject to the prior written approval of RailTel.

19.0 REMOVAL AND/OR SUBSTITUTION OF DEPLOYED PERSONNEL

If RailTel finds that any of the personnel deployed by the bidder for the various services, has, 1) committed serious misconduct or has been charged with having committed a criminal action, or 2) RailTel has reasonable cause to be dissatisfied with the performance of any of the deployed personnel in ensuring the proper services, then the bidder shall, at RailTel's written request specifying the grounds thereof shall provide suitable substitute of the personnel.

The bidder shall have no claim for additional costs arising out of or incidental to any removal and/or substitution of personnel.

20.0 LIABILITY FOR DEPLOYED PERSONNEL

- a. All persons deployed, in ensuring services with RailTel, by the bidder shall be engaged by them as their own employees/workers in all respects and the responsibility under any statutory enactments in respect of all such personnel shall be that of the bidder. The bidder shall indemnify RailTel against all claims whatsoever arising in respect of the said personnel under any statute/law in force. The bidders shall also engage the existing the staff already working in RailTel on the roll of the firm.
- b. The agency should verify/ascertain ensure before deploying a outsource resources regarding his satisfactory character& antecedent records.

21.0 OBLIGATIONS OF THE CORPORATION

RailTel shall provide the bidder such reasonable assistance as may be required in order to carry out the assignment.

22.0 PAYMENTS TO THE BIDDER

The consideration will be paid by RailTel to the bidder against monthly invoices raised on completion of each month for the services provided, by the bidder in duplicate. Such payments shall be made within fifteen days of the receipt of the said invoices along with required documents. TDS will be deducted as per prevailing rates. The consideration aforementioned is all inclusive and no other amounts will be payable to the bidder by RailTel on any account whatsoever, unless otherwise specifically agreed to in writing.

The tax invoice will be supported by the following documents:

- 1. Salary sheet for the month with details of allowances &recoveries,
- 2. EPF challans,
- 3. ESI challans,

- 4. Bank Statement as proof of payment to employees,
- 5. Certificate pertaining regarding compliance of Shramikkalyan portal as per clause 16.4,
- 6. Any other documents, if required.

23.0 GST related clauses

- a Bidder shall issue valid tax invoice to RailTel for availing proper credit of CGST/SGST/IGST/UTGST in case of award of contract. GST will not be reimbursed in the absence of valid tax invoice
- b. For all the taxable supplies made by the vendor, the vendor shall furnish all the details of such taxable supplies in the relevant returns to be filed under GSTAct.
- c. If the vendor fails to comply with any of the above, the vendor shall pay to purchaser any expense, interest, penalty as applicable under the GST Act.
- d. In case of incorrect reporting of the supply made by the vendor in the relevant return, leading to disallowance of input credit to purchaser, the vendor shall be liable to pay applicable interest under the GST Act to the credit of purchaser. The same provisions shall be applicable in case of debit/credit notes.
- e. Wherever the law makes it statutory for the Purchaser to deduct any amount towards GST at sources, the same will be deducted and remitted to the concerned authority.
- f. In regards to works contract, the tenderer should have registration no. for GST in respective state where work is to be executed and shall furnish GST registration certificate along with Tender.
- g. The imposition of any new tax and/or increase/in the aforesaid taxes, duties levies, after the last stipulated date for the receipt of tender of tender including extensions if any and the Bidder there upon necessarily and properly pays such taxes/levies /cess, the Bidder shall be reimbursed the amounts paid, provided such payments, if any, is not in the opinion of RailTel attributable to delay in execution of work within the control of the Bidder. The Bidder shall, within a period of 30 days of the imposition of any such tax or levy or cess, give a written notice thereof to RailTel that the same is given pursuant to this condition, together will all necessary information including details of input credit relating thereto. In the event of non-payment/default in payment of any of the above taxes, RailTel reserves the right to with-hold the dues/payments of Bidder and make payment to State/Central Government authorities as may be applicable. However, if the rates are reduced after the last stipulated date for receipt of tender, Bidder has to pass on the benefits to RailTel.
- h. In case the successful tenderer is not liable to be registered under CGST/IGST/UTGST/SGST act, the Railtel shall deduct the applicable GST from his/their bills under Reverse Charge Mechanism(RCM)and deposit the same to the concerned Tax Authority.

24.0 CORRUPT OR FRAUDULENT PRACTICES

RailTel expects the highest standard of ethics during the selection and executions of such contracts In pursuance of the above objective, the following defines, for the purposes of this provision, the terms set forth below as follows:

 a) "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in contract execution;

- b) "Fraudulent Practice" means misrepresentation or omission of facts or submission of fake/forged documents in order to influence a selection process or the execution of a contract to the detriment of RailTel.
- c) "Coercive Practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process, or affect the execution of contract.

RailTel reserves the right to inspect the accounts and records of the bidder relating to the performance of the contract and to have them audited by auditors appointed by RailTel.

25.0 SCOPE OF SERVICE

In performing the terms and conditions of the Contract, the bidder shall at all times act as an Independent bidder. The contract does not in any way create a relationship of principal and agent between RailTel and the bidder. The bidder shall not act or attempt or represent itself as an agent of RailTel. It is clearly understood and accepted by both parties that this Contract between the parties evidenced by it is on a Principal to Principal basis and nothing herein contained shall be construed or understood as constituting either party hereto, the agent or representative of the other, under any circumstances. The deployed personnel/employees of the bidder shall never, under any circumstances whatsoever, be entitled to claim themselves to be the employees of RailTel.

26.0 ARBITRATION

In the event of any dispute arising amongst the Parties, the Parties agree to use their best efforts to attempt to resolve all disputes in prompt, equitable and good faith. In the event of Parties are unable to do so, then such dispute shall be finally resolved by arbitration. The arbitration shall be conducted in English language and the venue of the arbitration shall be **Secunderabad**. The arbitration shall be as per Arbitration and Conciliation Act.

26.1 SETTLEMENT OF DISPUTE AND ARBITRATION

Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof shall be settled by a sole arbitrator in accordance with provisions contained in Arbitration and Conciliation Act, 1996 as amended and the award made in pursuance thereof shall be binding on the parties. The venue of such arbitration or proceedings thereof shall be Secunderabad.

All arbitration proceedings shall be conducted in English. Resources against any Arbitral award so rendered may be entered into court having jurisdiction or application may be made to such court for the order of enforcement as the case maybe.

The Arbitral Tribunal shall consist of the sole Arbitrator if the value of claim is up-to Rs. 10 lakhs. The arbitrator will be by the Chairman &Managing Director of RailTel Corporation of India Limited. If the value of claim or amount under dispute is more than Rs. 10 lakhs, the matter shall be referred to the adjudication of arbitral council. Chairman & Managing Director/ RailTel shall furnish a panel of three names to the contractor, out of which contractor will recommend one name to be his nominee and then Chairman &Managing Director/RailTel shall appoint out of the panel one name as RailTel's nominee and these two arbitrators with mutual consent appoint a third arbitrator who shall act as deciding arbitrator. The award of the Sole arbitrator or the Arbitral council, as the case may be, shall be final and binding on both the parties, i.e. Contractor and RailTel.

RailTel/EOI/SR/Outsources-manpower/P&A/2020-21/28-32

Each of the parties agree that no withstanding that the matter may be referred to Arbitrator as provided herein, the parties shall nevertheless pending there solution of the controversy or disagreement continue to fulfill their obligation under this Agreement so far as they are reasonably able to do so.

26.2 JURISDICTION

The Parties hereby irrevocable consent to the **sole jurisdiction of the Courts of Secunderabad** only in connection with any actions or proceedings arising out of or in relation to this proposal.

The Monthly consideration payable by RAILTEL to the AGENCY for the Services

RAILTEL, after complying with all statutory requirements and deduction of any tax or other amounts as required by law or as provided herein.

The consideration aforesaid will be paid by RAILTEL to the AGENCY, against monthly invoices raised at the end of each month, including the service charge by the AGENCY in duplicate, Such payments shall be made within fifteen days of receipt of the said invoices. The Consideration aforementioned is all inclusive and no other amounts will be payable to the AGENCY by RAILTEL on any account whatsoever, unless otherwise specifically agreed to by it in writing.

The AGENCY agrees that if and when so requested by RAILTEL, it will provide the placement Services at the premises, or any other offices of RAILTEL, as may be required by RAILTEL and at rates not exceeding the prevailing rates agreed between the parties and referred to in the Annexure-I here to.

2 OBLIGATIONS OF THE AGENCY

The AGENCY will for the purpose, continuously monitor the services being rendered by it to ensure that these are up to the standards required by RAILTEL.

The AGENCY would comply with the statutory requirement <u>EPF/ ESI</u> of the temporary personnel engaged by the client to the satisfaction of RAILTEL. They shall communicate any information required on this to RailTel or statutory agency as required.

The AGENCY to comply with all the provisions of labour laws such as <u>ESI ACT, EPF</u> and other statutory requirements. In event of non-compliance of the same the AGENCY to undertake to indemnify RAILTEL on any cost it may incur on account of such noncompliance.

The AGENCY shall ensure complete compliance in respect of the personnel employed by him and posted in RailTel of all the provisions of the Payment of Wages Act, 1936, Minimum Wages Act, 1948, Workmen's Compensation Act, 1923, Contract Labour (Regulation and Abolition) Act, 1970, Employee's Provident Funds & Miscellaneous Provision Act, 1952 and any other Act, Rules or Regulations for labour as may be enacted by the government or any modification thereof or any other law relating thereto and rules made there under from time to time.

The attendance rolls for the personnel deployed by the AGENCY at the premises of RAILTEL shall be provisioned by the AGENCY and it shall be monitored by the AGENCY. These <u>Attendance rolls shall be signed by the proprietor of the AGENCY or his authorized representative.</u>

Upon a written / oral request being made by RAILTEL in that regard the AGENCY will, within 24 hours of receipt of such request, discontinue the Services found to be unsatisfactory or otherwise objected to by RAILTEL for any reason and shall promptly take action with a view to continue rendering satisfactory services. On receipt of this request, RAILTEL will not be obliged to pay the amount in respect of discontinued Services.

RailTel/EOI/SR/Outsources-manpower/P&A/2020-21/28-32

Notwithstanding anything herein contained, the AGENCY will be liable to adequately compensate RAILTEL for any loss or damage occasioned by any act, omission or lapse on the part of the AGENCY or of any persons deployed by it pursuant to this Agreement.

The AGENCY is aware that Services similar to those covered by this Agreement are being or may hereafter be rendered in the premises by other entities also and will not, at any time, object to or interfere in any manner with the rendering of such Services by any such other entities.

The AGENCY shall, at all times, take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or amongst its employees and for the preservation of peace and protection of person(s) and property in the works: neighborhood of the works, against the same.

Maintenance of all types of records in respect of the personnel's deployed by the AGENCY shall be the responsibility of the AGENCY.

The agency will fulfill all the statutory compliance e.g. GST etc. in case of default of noncompliance of statutory compliances, RailTel reserves the right to terminate the contract and recover the amount along with interest and penalties without any notice.

3 OBLIGATIONS OF RAILTEL

RAILTEL will subject to compliance to this Agreement and all statutory requirements and the provision of Services to its satisfaction by the AGENCY and subject to <u>deduction of tax at source under</u> the Income Tax Act, 1961 or any other provisions of law for the time being in force, ensure full and timely payments for the Services as provided with this Agreement.

The Following are the terms and conditions of the engagement:-

- a) The engagement if temporary is purely temporary and on Contract basis.
- b) The offer is based on the Contract between RAILTEL and THE AGENCY for providing services which is only for a specific period, which may however be extended depending or the extension of the Contract and also on the basis of the performance. The services may be terminated with a notice of one month.
- c) The service of the temporary engaged are liable to the transferred anywhere within Southern Region, from one job to another, one department to another, and one branch to another without any extra remuneration depending on the exigencies of the work.
- d) The temporary engaged shall at all time maintain absolute integrity and devotion to duty and conduct himself in a manner conductive to the best interests, credits and prestige of RAILTEL.
- e) By virtue of the services with the RAILTEL, you and the temporary engaged will come in possession of certain information and secrets related to RAILTEL you or temporary engaged personnel will not divulge any such secret, formula or business strategies to any other person or any organization or individual.
- f) The temporary engaged persons so deployed by the AGENCY in RAILTEL shall not have claim to any regular employment in RAILTEL.

g) RAILTEL may at its discretion award/reward/incentives to efficient temporary engaged person(s) directly at anytime.

The AGENCY shall ensure that complete confidentiality is maintained by it and all its temporaries, with regard to all information relating to RAILTEL, its premises, clients, business assets, affairs and employees and that neither the AGENCY nor its persons will any time divulge or make known to any third parties, any trust, accounts, matters or transaction whatsoever pertaining to RAILTEL and its associate entities and which may in any way come to their knowledge or attention.

4 FORCE MAJEURE

The obligations of RAILTEL and the AGENCY shall remain suspended if and to the extent that they are unable to carry out such obligations owing to force majeure or reasons beyond their control. In the event of such inability continuing for more than a week, the other party shall have a right to terminate this agreement without further obligation.

5 INDEMNITY

The AGENCY hereby agrees to keep indemnified and shall keep indemnified and hold harmless, RAILTEL and its Directors, Officers and employees from and against all and any claims, demands, losses, damages, penalties, expenses and proceedings connected with the implementation of this Agreement or arising from any breach or non-compliance whatsoever by the AGENCY or any of the persons deployed by it pursuant hereto of or in relation to any such matter as aforesaid or otherwise arising from any act or omission on their part, whether willful or not, and whether within or without the premises. The agency will indemnify RailTel for any act of commission including fraud, embezzlement etc.

6 OTHER TERMS AND TERMINATIONS

Agreement shall be deemed to have commenced as on and from (<u>Date</u>) and shall be in force for an initial period of One Year from the said date. Any change in the consideration agreed under clause 1.3 above, beyond this period would be by way of mutual consent and in writing only. Thereafter, the parties may extend the Agreement on terms to be mutually agreed upon.

Notwithstanding anything contained herein either party may, without cause, terminate this agreement by giving to the other 60 days written.

Expiry or earlier termination of this Agreement will not prejudice any rights of the parties that may have accrued prior thereto.

7 NO-AGENCY

It is clearly understood and accepted by both parties that this agreement between the parties evidenced by it is on a Principle to Principle basis and nothing herein contained shall be construed or understood as constituting either parties hereto, the agent or representative of the other, under any circumstances.

8 ENTIRE AGREEMENT

This agreement embodies the entire Agreement and understanding between the parties as to the subject matter hereof and supersedes all prior negotiations, arrangements, agreements and

understanding between the parties. Any changes in the terms of the document can only be made in writing and by mutual agreement.

All other terms & conditions are as per EOI document.

9 ARBITRATION

In the event of any dispute arising amongst the Parties, the Parties agree to use their best efforts to attempt to resolve all disputes in prompt, equitable and good faith. In the event the Parties are unable to do so, then such dispute shall be finally resolved by arbitration. Each party shall appoint the third arbitrator. The arbitration shall be conducted in the English language and the venue of the arbitration shall be in Secunderabad, Telangana.

10 JURISDICTION

The parties hereby irrevocably consent to the sole jurisdiction of the Courts of Secunderabad, Telangana in connection with any actions or proceedings arising out or in relation to this Agreement.
