**Corrigendum -IV**

**Sub:** Request for proposals for “Selection of Consultant for registration of RailTel’s station wi-fi project under “Claim Endorsement Record (CER) Category” in Guinness World Record”.

**Ref:** This office Tender No. RailTel/RFP/CO/ITP/2020-21/GWR-Wi-Fi/01dated 28-Apr-2020

In reference to the above referred tender the following amendment are issued under the Corrigendum-II. The bids may be submitted in consideration of this amendment.

**1. Clause 2.1.3 of Section-2 “Eligibility & Evaluation Criteria” may be read as:**

Having at least ONE such GWR based inhouse or third-party work experience

**2. Clause 2.1.4 of Section-2 “Eligibility & Evaluation Criteria” may be read as:**

Minimum annual turnover of at least Rupee Five crores during the last three years. Turnover for FY 16-17, FY 17-18 and FY 18-19 shall only be considered to evaluate the compliance to this criterion

**3. Clause 2.1.5 of Section-2 “Eligibility & Evaluation Criteria” may be read as:**

Organization with professionals (manpower) having relevant background expertise with Guinness World Record for its clients. Supporting documents may be submitted. CV's of respective professionals, correspondence with clients for third party or with GWR in case of inhouse certification also need to provide to validate self-certification. CV's must be certified by authorized person of successful bidder's organization" has to be issued and approval of C.A. required

**4. Clause 2.4 of Section-2 “Period of Association” may be read as:**

Validity of the association is 90 days with further extendable as per requirement of GWR work without LD clause.

**5. Sub-Clause 3 of Clause 6 of Section-6 “Special Terms and Conditions of Contract” may be read as:**

The bidder should furnish a declaration from the engagement partner (partner/ director engaging with RailTel for this RFP) stating that he/ she has NO interest in any other bidders in respect of the same tender

**6. Sub-Clause 6 of Clause 6 of Section-6 “Special Terms and Conditions of Contract” may be read as:**

RailTel shall have the right to terminate the contract by giving 30 days’ notice without assigning any reasons thereof. However, in the event of any breach of terms and conditions of the contract, RailTel will have right to terminate the contract by written notice to the Seller.

**7. Clause ‘a’ of Section-7 “Other Important Terms of Contract” may be read as:**

The selected bidder may outsource part of work to any other associate/ franchisee/ third party in circumstances where GWR mandatorily requires such other associate/ franchisee/ third party (research agency, independent auditor etc)"

**8. The last date of submission of bids is extended from 10.06.2020 up to 15.00 Hrs. to 16.06.2020 up to 15.00 Hrs. Tender will be opened at 15:30 Hrs. on 16.06.2020**

Other terms and conditions are remained same.
