The offer shall be addressed to Executive Director, RailTel Corporation of India Ltd., Eastern Region, Kolkata – 700 071. Tender will be opened at the office of Executive Director, RailTel Corporation of India Ltd., Eastern Region, Kolkata – 700 071 in presence of tenderers who choose to be present.

Each vehicle provided on hire basis shall be treated as a **separate tender** and separate EMD shall be submitted for each.

Fulfillment of eligibility criteria as mentioned in the Tender document is a pre-requisite for consideration of the offer. If a tenderer submits offer for more than one vehicle, then the sum of the credentials required for each vehicle for which participated shall have to be fulfilled by the tenderer for qualifying. In case of part fulfillment of the criteria, RailTel shall at its discretion, discard any of the offer received in which the tenderer has participated and take into consideration any of the vehicle for which total eligibility criteria matches with those available with the tenderer.

The rates quoted by the tenderer in hiring of one vehicle shall have no bearing on other vehicle. Each car hiring shall be treated as a separate tender and tender finalized accordingly.
