k)	The rates should be inclusive of taxes. The tenderer has to submit the breakup of all taxes at the time of submission of their "on account bills" also. The tenderer has also to submit their TIN No., PAN No. & GST No. at the time of submissions of their "on account bills. In addition to it, the contractor should submit copy of GST registration certificate for the states wherever applicable. PF Account & ESI registration no. should also be available with the contractor. All the statutory provisions have to be made by the contractor.

Small Scale Units, if registered with NSIC for the item tendered, under single point registration scheme, copy of valid registration certificate for exemption of tender cost, is to be submitted However, postage charges of Rs. 590/- would have to be paid by them, in case they need tender document by post.

The offers shall be opened on above said date in the presence of those bidders who choose to be present. If the above said date happens to be a holiday the same shall be opened on the next working day.

Eligibility Criterion:

i. Technical Eligibility:

- The tenderer should have satisfactorily completed in the last three financial year (i. e. current year up to date of opening of tender and three previous financial years) at least one similar single work for a minimum value of 35% of the advertised tender value of the work. The work should have been executed for Govt/PSUs/Telecom Service Providers/Infrastructure Providers.
- Similar nature of work physically completed within the qualifying period, i.e. the last 3 financial year and current financial year up to date of opening of tender (even though the work might have commenced before the qualifying period) shall only be considered in evaluating the eligibility criteria
- The total value of similar nature of work completed during the qualifying period and not the payments received within qualifying period alone, shall be considered

Definition of similar single work is as under:


"Maintenance or erection of MW/UHF/Cellular Towers"

- Financial Eligibility:** The total contract amount received by the tenderer during the last three years should be a minimum of 150% of the advertised tender value of the work. (Last audit report from registered Chartered Accountant to be enclosed)

Note : In case the tenderer wants to quote for multiple Groups, the financial and technical criterion given above will have to be separately meet for each Group being quoted, i.e. for 2 Groups, tenderer should have capability equal to sum of the separate capabilities of those 2 Groups.

Note:

- JV/Consortium bid is not allowed.
- Price Variation Clause is not applicable in this tender.
