New Condition:

In case of submission of bid by Parent/100% subsidiary company, following be noted:

- a. Bidder shall submit legal documentary proof for parent and subsidiary company along with bid
- b. EMD shall be submitted by the lead bidder
- c. Parent Company or 100% Subsidiary Company or both together, shall fulfill the Eligibility criteria as per clause- 15 of section-II, chapter-I.
- d. Along with the bid, the Parent and 100% Subsidiary Company shall submit an irrevocable undertaking duly signed by both Parent and 100% Subsidiary, stating that all of them i.e. Parent and 100% Subsidiary Company shall be liable for due performance of the contract jointly and severally, failing which, both of them shall be liable to be barred from having business dealing with RailTel for a period of three (3) years.
- e. Both the Companies should submit all the details as per tender requirement and MOU between Parent and 100% Subsidiary Company shall be submitted by the bidder along with bid
- f. If tender is successful, two separate Purchase Orders for Part-A & B i.e. VSAT System Hardware supply & installation portion and for Part-C i.e. for Bandwidth service portion shall be placed on Parent/100% subsidiary company based on the request from the bidder.
- g. If tender is successful, SD/PBG shall be submitted by the Parent and 100% subsidiary company as per the Purchase Orders. Both Parent Company and 100% subsidiary Company shall submit a declaration stating that in case of breach of contractual obligation on any of the Purchase Orders, RailTel reserves the right to forfeit the instruments submitted by both of them.
- h. Agreement shall be signed by both Parent and 100% subsidiary company

All other terms and conditions of tender remain the same.
