In addition to it, the contractor should submit copy of WCT registration certificate for the states wherever applicable.

**Eligibility Criteria:** As per para no.4 in the preamble of Tender document

**The tender document should be sealed in a cover duly superscripted tender No., and name of the work** and shall be dropped in the Box kept in the office of Executive Director/Southern Region, RailTel, Second floor, B-Block, Rail Nilayam, Secunderabad, as mentioned above. RailTel is not responsible for delay or loss in transit. The tenderer may be present at the time of opening of tenders, if they desire. Late/delayed/ incomplete tenders and tenders with insufficient EMD will be summarily rejected (**see Note for exemption**).

**Note:** Firms registered with NSIC or any other body specified by Ministry of MSME for the tendered item/ work is exempted from submission of cost of tender & EMD. However, postage charges of Rs.500/- would have to be paid by them, in case they need tender document by post. Firms claiming for the above exemptions under NSIC/MSME or others, have to submit supporting documents as per clause no.10 of “Preamble” without which their offer will be considered as invalid and summarily rejected.
