## **Back Ground and Introduction**

## 1. Background:

RailTel Corporation of India Limited, a Government of India Undertaking, under Ministry of Railways has been nominated by Ministry of Railways to provide 3G/4G and above based Mobile (Cellular) Connections in nationwide CUG configuration for Railway officers & supervisors on All India basis.

It is worth mentioning here that Indian Railways is presently using an existing CUG, provided by M/s Bharti Airtel Limited. The same subscriber numbering scheme of all users shall be required to be continued, as per provisions of Mobile Number Portability in all the telecom circle.

## 2. Introduction:

Request for Proposal (RFP) is being invited for selecting a service provider to provide about 3,78,000 no. of 3G/4G and above based Mobile Communication Services for Railway personnel on All India Basis for a period of 3 years with the provision for further extension by one more year.

## **CHAPTER-I**

## **ELIGIBILTY CRITERIA**

## 1.1 Eligibility Criteria:

The bidder must have the following:

- i) Operator should have PAN India presence to cover all Divisions, Zones, Producton Unit, PSUs and other associated offices of Indian Railways.
- ii) Must be operational with 3G/4G and above technology based Cellular Services in all the 23 telecom Circles of India.

## 1.2 Terms and Conditions:

- i) Uniform numbering scheme should be adopted. As the mobile number portability is in vogue, all existing existing mobile numbers should be retained in case of change in service provider. The bidder should give compliance to be capable to use the existing mobile numbers along with the existing numbering scheme, as per provisions of Mobile Number Portability without any extra cost to the Purchaser.
- ii) Post contract activities like coverage issues, billing and payment should be handled by respective Railways directly.
- iii) Quality of service should be as per TRAI guidelines.
- iv) Emphasis shall be given to select Telecom Service provider, which has the sufficient overall coverage on IR. Telecom Service Provider should also undertake with in a time bound period to improve track coverage where the same is in-adequate. In case of non-compliance to improve network coverage, penalty will be imposed as per tender.

## a. Coverage of Cities / Towns – Appendix G

The bidders should have 100% network coverage at Railway Board, all Railway Zones & Divisional Headquarters and 90% on other important locations where the mobile connections are proposed to be supplied. Bids of tenderers not complying to 100% network coverage at Railway Board, all Railway Zonal & Divisional Headquarters and 90% on other important locations as detailed above will not be considered technically suitable.

Details of all such Cities/Towns where coverage is required is enclosed as Appendix G. Availability of coverage at all the locations is required to be submitted as per format in Appendix G. The purchaser shall be free to verify any coverage data and same shall be arranged by the bidder on short notice.

## b. Coverage along the Railway Track. - Appendix F

Details of coverage along various track sections should be submitted as per format in Appendix – F. The network coverage along the railway track should not be less than 80%, averaged over all the sections of Indian Railways, failing which the bid shall not be considered for evaluation.

- c. Bidder should enhance the coverage by 92.5% in 0-6 months (Phase-I), and up to 95% in 7-12 months (Phase-II). Bidder should submit the undertaking for enhancement on company's letter head as per format (Appendix-I). Network Enhancement along with Railway track/ Railway area shall be monitored at Zonal Railways level and in case service provider fails to provide target coverage of 92.5% in Phase-I, 95% in Phase-II, then penalty of 5% after Phase-I and 10% after Phase-II shall be imposed on monthly basis, till the Network Enhancement as per terms and condition of contract is achived. Maximum penalty should be 15% (of the monthly billed amount) only for network coverage related issues.
- v) In case of BSNL, it would be BSNL's responsibility to co-ordinate with MTNL to provide the services in Mumbai & Delhi as per the accepted terms & conditions of the contract and a certificate to this effect from MTNL must form part of BSNL's offer.

## vi) State of art Network Management Center and Network Operation Center.

The bidder must have facility for providing customer support and troubleshooting round the clock at locations where the Mobile Connections are required to be provided. Address and contact telephone numbers of the Contact/Customer Care Centre for the same should be provided along with the offer so that user can log their complaint directly to the TSP call centers.

## 1.3 Scope of work:

## 1.3.1 Mobile (cellular) Connections in CUG configuration:

- i) Indian Railways require CUG scheme based on 3G/4G and above technology for Mobile (cellular) Connections under CUG facility for employees of Indian Railways at its various offices on All India basis. The bidder shall provide SIM Cards at all the locations of Indian Railways on all India basis as per the Bill Plan decided by M/s RailTel. Number of Connections will be to the tune of 3,78,000 +/- 30% considering requirement of Railway officials on All India Basis. The requirement will be distributed in 3 different categories based on requirements of Senior, Middle & Lower level Management as per tentative distribution as indicated in Appendix-B. Actual distribution may vary on different Zonal Railways.
- ii) The CUG Services should be based on 3G/4G and above.
- iii) Telecom Service Provider (TSP) should provide Data Plan bundled with Data per day or monthly basis with free unlimited Local and STD voice incoming & outgoing calls, Roamming and 100 SMS daily local & National.

No extra charges whatsoever would be applicable for various services including Voice Calls, SMSs & Roaming, within India other than bundled Data.

iv) The only differentiation would be basis the quantity of Data bundled in each plan category.

## 1.4 Essential Requirements of Railways:

## i) Closed User Group facility:

All the 3G/4G and above technology Based Mobile Connections to be procured from the bidder needs to be have All Incoming & Outgoing calls to any other number at any opretor in India free. Likewise, SMS and other facilities available will also be free for CUG users. The bidders should specify the other available facilities proposed to be offered for the CUG users in their offer.

## ii) Call Conferencing:

Indian Railways needs this facility so that the CUG subscribers of Indian Railways can talk to multiple users simultaneously in conference with cascading.

## iii) Roaming Facility:

The bidder needs to have the desired nos of interconnect with other operators both on National & International basis for providing National & International Roaming to other networks.

The bidders are required to submit details of National Operators & Countries covered as well as the tie-ups with International operators for National/International Roaming in their bid offer.

## iv) High Speed Data Connectivity:

The bidder needs to have the facility to provide the high speed Data connectivity to the CUG users of Indian Railways on all India basis

## v) For Network enhancement in isolated/remote Railways areas:

RailTel shall pursue with Ministry of Railways for erecting of Tower/Mast/Pole Mount on Railway areas against license fess for improvement of CUG coverage in these Railway areas/sections to meet the requirement of Railways.

vi) The last 4 digits of the CUG Mobile Connections from 0000 to 9999 should be kept reserved for Railways, to the extant possible, in which Railway will select their numbers as per the Numbering Scheme prevalent in each Telecom circle in India. Railways would be provided contiguous numbers in each circle.

Final numbering scheme will be decided at time of implementation of the scheme based on mutual consent. The telecom operator selected through the bidding process, would be required to port all existing CUG numbers to their network.

vii) The ISD facility on the Mobile Phones/ Connections should be activated by the Service Provider within one hour of the logging of the request for the same. Firm will also furnish ISD rates in Appendix-H.

- viii) Any subscriber of PSTN network or any other cellular, fixed network should have access to any of the subscribers of the CUG & vice versa.
- ix) Caller Line Identification shall be provided to all connections free of charge.
- x) As call charges for Telecom facilities are under review from time to time, the benefits of the same shall be passed on to subscribers of the Closed User Group.
- xi) National Incoming & Outgoing Roaming facility should be available on all connections and would be unlimited free.
- **xii)** Other standard facilities available in the network like barring of calls etc. to a certain group of subscribers as requested by Railways from time to time should be possible to be provided.
- **xiii)** The SIM cards for activation of the mobile connections shall be provided by the bidder free of cost. No activation charges, registration charges and security deposits shall be paid by the Railways.
- **xiv)** It should be possible for each user to see his/her bill details on the website of the service provider using a password.
- **xv)** Billing accuracy will be of utmost importance. In case of surrender /closure of any SIM account or handover to another user for want of change of user, the bill on settlement has to be full and final till the period of use. No supplementary bills for the period settled will be entertained under any circumstances and the service provider has to bear the losses, if any, for want of transfer of billing details from various participating circles.
- **xvi)** The ringback tone on the CUG phones shall have message/caller tune advised by Railways without any additional charges.
- **xvii)** Number series with sufficient numbers to accommodate future expansions in various categories should be allotted by the service provider.
- **xviii**) Coordination meeting at Railway Board, Zonal HQ, Division HQ, PU's & other offices should be held every Quarter. RailTel and Telecom Service provider (TSP) should nominate officials for coordination with each unit within the first week of issuance of acceptance letter to TSP.
- xix) TSP should provide information regarding user-wise accrued charges & details of voice call & data usage both through online and through app for easy access by each CUG user and coordinators. Railway coordinator should be able to access billing details of all users under his accounting unit for complete period of contract.
- xx) Incoming & Outgoing Call Data Record (CDR) of crew (LP/ALP & Guards) should be shared in excel format by Telecom Operators, as and when required by Railways for accident enquiries.

**xxi)** TSP should submit report regarding improvement in network one week before the quarterly coordination meetings. In addition, TSP should also provide details \* as given under.

- xxii) Sixteen (16) dedicated Service executives as single point of contact (SPOC) to be nominated in 16 zones of Indian Railways across India. They have to ensure and lead all pre-service, Sales & Network Related issues, attending monthly review meetings at Railways division/zone. They may be seated at Railway Zonal HQ for propoer coordination.
- xxiii) Two (2) senior manager level dedicated Single Point of Contact (SPOC) to be nominated for national support for coordinating with Railway Board level and RailTel (1 at Railway Board & 1 at RailTel) for all pre & post service support related issues across across India and updating the same at Board Level/Railtel HQ at agreed time period/interval. He should also lead all pre and post service related monthly review at Railtel/Railway board with agenda of discussion from Railtel. The service issues led by national SPOC of service provider must include pre on board, post on board and network related issues. He may be seated at one of the assigned Railtel offices in Delhi/NCR as per requirement of Railways/RailTel.
- **xxiv)** Safe custody of backup SIMs, if taken by Railway zone/division should be valid for minimum of 3 months.
- **xxv)** As per TRAI regulation, 100 SMSs /day or a maximum of 3000 SMSs /month should be allowed. However, any change in TRAI guidelines on above would apply on services provided under this contract.
- **xxvi)** It shall be possible to send group massages to CUG subscribers at PAN India level, Zonal Level, Divisional Level, PU's Level, Training Institute Level etc. as per Railways requirement.

Note: Railway will continuously moniter health of system from network point and customer satisfaction.

#### 1.5 Issue of Purchase Order:

Against Requirement of Railway Board, Zonal HQ, Division HQ, PU's, PO will be issued from RailTel. Firm will not entertained requirement forwarded from other than RailTel.

## **CHAPTER-II**

#### GENERAL GIUDELINS FOR BIDDING

## 2. General Bidding Guidelines:

RailTel seeks to identify a bidder for provision of Mobile Communications Facility - CUG for Indian Railways on All India basis, by way of the Bidding Process undertaken in terms of this RFP and all other Bidding Documents.

## 2.1 RFP Response / Deviation Statement:

The bidder shall go through the entire document and must comply with all the terms and conditions. A compliance statement in form of **Complied or Not-Complied** shall be given against each item and specification of the tender document. The compliance statement should be supported by authentic documentation. In this regard, Bidders shall give an undertaking on to the effect of its compliance with the aforesaid and confirming the authenticity of the supporting documents. All information desired vide various clauses of the RFP should be submitted along with the Technical Offer.

Please note that any deviation from the laid down requirements/specifications shall be brought out separately in a **Deviation statement** to be attached. In case of no non-compliance/deviation, the deviation sheet shall be crossed with NIL Deviation mark diagonally. Each page of the bid and cutting/corrections shall be duly signed and stamped by the bidder. Failure to comply with these requirements may result in the bid being rejected. The format of Deviation Sheet is at Appendix D. Bidders should sign on each page of this RFP document and submit the same along with their offers in token of having read each and every clause of the RFP.

#### 2.2 Technical Literature and Brochure:

One set of detailed technical literature shall be submitted in English along with the bid. The literature shall contain detailed specification and information about all the modules of the service. The technical literature will be used to compare the specifications of the offered services vis-à-vis the required specification mentioned in this tender.

## 2.3 Submission of Proposals:

The proposals shall be submitted in sealed single packet super-scribed as Response to RFP for Provision of Mobile Communications Facility - CUG for Indian Railways on All India basis as details given under:-

#### 2.3.1 EMD and Tender Fee:

a. Bidder should submit Earnest Money Deposit (EMD) amount of Rs. 52.31 Lakhs (Rs. Fifty-Two Lakhs Thirty-One Thousand Only). EMD shall be furnished in form of a Demand Draft (DD) in favour of RailTel Corporation of India Limited payable

at New Delhi from a reputed bank. Any bid not accompanied with the EMD will be summarily rejected.

- b. The EMD shall be returned to unsuccessful bidders after awarding of contract to successful bidder and EMD of successful bidder shall be returned after the submission of PBG in the manner as set out in this RFP, after execution of the Agreement.
- c. The Bidder agrees that the EMD amount is interest-free and shall be refundable to the unsuccessful Bidders without any accrued interest thereon.
- d. The EMD shall be forfeited as Damages without prejudice to any other right or remedy that may be available to RailTel under the Bidding Documents and/ or under the Agreement, or otherwise, if:
  - i. a Bidder submits a non-responsive Bid;
  - ii. a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice as specified in this RFP;
  - iii. a Bidder withdraws its Bid during the period of Bid validity as specified in this RFP and as extended by mutual consent of the respective Bidder(s) and RailTel; and
  - iv. the Successful Bidder fails within the specified time limit:

to sign and return the duplicate copy of LOA; or
to execute the Agreement; or
to furnish the PBG within the period prescribed therefore in the Agreement.

i. the Successful Bidder, having executed the Agreement, commits any breach thereof prior to furnishing the PBG.

## e. Tender Processing Fee:

Bidder shall submit tender fee of Rs. 11800/- (Eleven Thousand Eight Hundred Only including tax) along with EMD.

If, the Tender document is down loaded from the Internet Website, a Demand draft of Rs. 11800/- in favour of RailTel Corporation of India Ltd., payable at New Delhi is required to be included along with the offer.

## 2.3.2 Technical Requirement:

a) The Bid shall contain the documentary proof for eligibility criteria and complete technical proposal. The bid should include technical proposal with full details including description of hardware/equipments and services so as to enable technical

assessment of the proposal. This shall also include a categorical clause wise compliance statement. The technical bid must be submitted in a structured manner. No **brochures/leaflets etc**. should be submitted in loose form. The technical portion of the proposal should comprise of the following in that order: -.

- i) A letter of authority duly signed by an authorized signatory.
- ii) A brief covering the technical specifications of the service provider's / operator's network. (i.e. executive summary.) A detailed document on the service provider's network in terms of reliability & efficiency must also be submitted along with the bid.
- iii) Technical documentation i.e. Product brochures, leaflets, manuals etc.
- iv) Delivery and implementation schedule.
- v) Deviation / Nil Deviation Certificate as per Appendix D.
- vi) Address and contact telephone numbers of the Contact/Customer Care Centres for the services proposed to be provided to Railways.
- vii) A copy of SLA signed with any other organization along with a list of customers for similar type of services.
- viii) The original RFP document issued by this office duly signed on each page.
- ix) **Quality of Service**: Quality of Service parameters as stipulated by TRAI should be submitted as per details in **Appendix A**.
- x) All technical information required to be submitted against various clauses of the RFP.
- b) Detailed information on the bidder's experience in establishment/management of the services requested in this RFP should be provided. Incomplete proposal would be summarily rejected.
- c) The proposal shall be signed by the authorized person with the seal of the company on each page.
- d) One softcopy of the Technical Bid shall be submitted along with the bid. The soft copy of Appendix F & G should be in excel format only.

## **2.3.3 Price:**

- a. All prices should be quoted in Indian National Rupee (INR) and foreign Bidders should comply with all the rules and regulation of RBI, and the relevant Government instrumentality at their own cost.
- b. RailTel may at its sole discretion and in accordance with the terms of this RFP, declare the Bidder quoting the lowest Price Bid as the lowest bidder ("L1 Bidder").

- c. RailTel shall reserve the right to negotiate with the L1 Bidder for further reduction of the price.
- d. In the event of any difference between figures and words, the amount indicated in words in the Price Bid shall be considered.
- e. The price should be exclusive of all taxes which would be extra as per actuals.

## 2.4 Other conditions:

- a) Bid received after due date and time shall neither be opened nor considered and returned as it is.
- b) Proposals by e-mails or fax shall be out rightly rejected.
- c) The outer cover in which sealed covers are placed shall be addressed to Executive Director/DNM, RailTel Corporation of India Limited, 143, Institutional Area, Sector-44, Gurgaon-122003. This cover must be super-scribed with Response to RFP for provision of Cellular Phones under CUG Configurations for Railway personnel on All India Basis.
- d) Bids not containing complete information/documents in their technical bids are liable to be rejected.

## 2.5 Changes in the Tender Document:

- 2.5.1 At any time, prior to the Bid Due Date, RailTel may for any reason, whether on its own initiative or as a result of a request for clarification by a Bidder, modify the Bidding Documents by issuing an addendum in accordance with the provisions contained in this Clause.
- 2.5.2 In case any modification is made to the Bidding Document or any clarification is issued which materially affects the terms contained in the Bidding Document, RailTel shall publish such modification or clarification in the same manner as the publication of the initial Bidding Document.
- 2.5.3 In case, a clarification or modification to the Bidding Document is issued, RailTel may, prior to the Bid Due Date, extend such time limit in order to allow the Bidder sufficient time to take into account the clarification or modification, as the case may be, while submitting their Bids.
- 2.5.4 Provided, the Bid last submitted or the Bid as last modified by the Bidder shall be considered for evaluation.

## 2.6 Download of Tender Documents:

The Bidding Documents shall be available at RailTel website and bidder shall be permitted to download the bidding document from the website <a href="www.railtelindia.com">www.railtelindia.com</a> or <a href="www.tcil-india-electronictender.com">www.tcil-india-electronictender.com</a>.

## 2.7 Validity of Bids:

- 2.7.1 The bid shall be valid for a period of 60 days from the date of opening of the bid.
- 2.7.2 Prior to expiry of the period of validity of Bid, RailTel may request the Bidders to extend the validity of the Bid for an additional specified period.

#### 2.8 Clarifications:

- 2.8.1 The Bidder shall ensure that its queries prior to the submission of Bid, should reach RailTel by e- mail (in .xls / .doc format only) on or before last date for sending queries by the authorized representative of the Bidder only.
- 2.8.2 RailTel shall endeavor to provide timely response to the queries. However, RailTel does not guarantee as to the completeness or accuracy of any response made in good faith, nor does RailTel undertake to answer all the queries that have been posed by the Bidders. RailTel shall endeavor to respond to the queries within the period specified therein, but no later than 10 (Ten) days prior to the Bid Due Date.
- 2.8.3 At any time prior to the last date for receipt of Bids, RailTel may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder, modify the RFP by way of a corrigendum. The corrigendum (if any) and clarifications to the queries from all Bidders will be posted on RailTel and TCIL website i.e. <a href="www.railtelindia.com">www.railtelindia.com</a> & <a href="www.railtelindia.com">www.tcil-india-electronictender.com</a>. Any such corrigendum shall be deemed to be incorporated into this RFP. In order to provide prospective Bidders reasonable time for taking the corrigendum into account, RailTel may, at its sole discretion, extend the last date for the receipt of Bids.
- 2.8.4 Any queries or request for additional information concerning this RFP shall be submitted in writing by speed post/ courier/ special messenger or by e-mail so as to reach the designated officer of RailTel by the specified date in the Preamble. Any request for clarification received thereafter may not be entertained/ replied. The envelopes/ communication shall clearly bear the following identification/ title: "Queries/Request for Additional Information: RFP for "Provision of Mobile Communications Facility CUG for Indian Railways on All India basis". All relevant clarifications sought will be addressed during the pre-bid meeting.
- 2.8.5 RailTel shall endeavour to respond to the questions raised or clarifications sought by the Bidders. However, RailTel reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause shall be taken or read as compelling or requiring RailTel to respond to any question or to provide any clarification.
- 2.8.6 RailTel may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by RailTel shall be deemed to be part of the Bidding Documents. Verbal clarifications and

information given by RailTel or its employees or representatives shall not in any way or manner be binding on RailTel.

2.8.7 Notwithstanding anything contained herein, RailTel shall not be responsible for receipt of queries from the Bidders, it shall be the sole responsibility of the Bidder.

All queries, if any, in connection with this tender shall be sent to flowing officilas (in .xls/.doc format) & hard copy by post to RailTel Corporation of India Limited, 143, Institutional Area, Sector-44, Gurgaon-122003.

## 2.9 Disqualification of Bidder:

- 2.9.1 A Bidder shall be liable for disqualification and forfeiture of the EMD submitted by it, if any legal, financial or technical adviser of RailTel in relation to the Project is engaged by the Bidder, its members or any Associate thereof, as the case may be, in any manner for matters related to or incidental to such Project during the Bidding Process or subsequent to the (i) issuance of the LOA or (ii) execution of the Agreement.
- 2.9.2 In the event any such adviser is engaged by the Successful Bidder or the Contractor, as the case may be, after issuance of the LOA or execution of the Agreement for matters related or incidental to the Project, then notwithstanding anything to the contrary contained herein or in the LOA or the Agreement and without prejudice to any other right or remedy of RailTel, including the forfeiture and appropriation of the EMD or PBG, as the case may be, the LOA and/or the Agreement shall be liable to be terminated without RailTel being liable in any manner whatsoever to the Successful Bidder or Contractor for the same.
- **2.9.3** For the avoidance of doubt, this disqualification shall not apply where such adviser was engaged by the Bidder, its member or Associate in the past but its assignment expired or was terminated prior to the Bid Due Date.

## 2.10 Rejection and Return of Bids:

- 2.10.1 RailTel reserves the right to reject any or part of the bid without assigning any reason. The documentation submitted by the bidder shall not be returned. RailTel also reserves the right, at its sole discretion, not to award any order under the present RFP. RailTel shall not pay any costs incurred towards preparation and submission of the bid or any other expenditure incurred on this account. If a bidder gives wrong information in their bid, RailTel reserves the right to reject such bid at any stage or cancel the contract, if awarded, and forfeit the Earnest Money Deposit / Performance Bank Guarantee / Security Deposit.
- **2.10.2** Canvassing in any form in connection with the tender is strictly prohibited and the bids submitted by the bidders who resort to canvassing are liable to be rejected.
- **2.10.3** Should a bidder have a relation or relations employed in RailTel, the authority inviting the bids shall be informed of the fact along with the offer, failing which RailTel, at its sole discretion, may reject the bid or cancel the contract and forfeit the Earnest Money Deposit / Performance Bank Guarantee / Security Deposit.

#### 2.11 Site Visit and Varification of Information:

- 2.11.1 Bidder are encouraged to submit their respective Bids after visiting the sites relevant for the purposes of completion of Scope of Work of the Project and ascertaining for themselves the site conditions, location, surroundings, climate, availability of power, water and other utilities for construction, access to site, handling and storage of materials, weather data, regulations and any other matter considered relevant by them.
- **2.11.2** It shall be deemed that by submitting a Bid, the Bidder has:
  - i. made a complete and careful examination of the Bidding Documents;
  - ii. received all relevant information requested from RailTel;
  - iii. accepted the risk of inadequacy, error or mistake in the information provided in the Bidding Documents or furnished by or on behalf of RailTel relating to any of the matters referred to in Clause 2.11.1 above;
  - iv. satisfied itself about all matters, things and information including matters referred to in Clause 2.11.1 hereinabove necessary and required for submitting an informed Bid, execution of the Scope of Work of Project in accordance with the Bidding Documents and performance of its obligations/compliance with all of the requirements, as set out under the Bid Documents;
  - v. acknowledged and agreed that inadequacy, lack of completeness or incorrectness of information provided in the Bidding Documents or ignorance of any of the matters referred to in Clause 2.11.1 hereinabove shall not be a basis for any claim for compensation, Damages, extension of time for performance of its obligations, loss

- of profits etc. from RailTel, or a ground for termination of the Agreement by the Contractor;
- vi. acknowledged that it does not have a Conflict of Interest; and
- vii. agreed to be bound by the undertakings provided by it under and in terms hereof.
- 2.11.3 RailTel shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the Bidding Documents or the Bidding Process, including any error or mistake therein or in any information or data given by RailTel.

## 2.12 Verification and Disqualification:

- 2.12.1 RailTel reserves the right to verify all statements, information and documents submitted by the Bidder in response to the Bidding Documents and the Bidder shall, when so required by RailTel, make available all such information, evidence and documents as may be necessary for such verification. Any such verification, or lack of such verification, by RailTel shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of RailTel hereunder.
- **2.12.2** RailTel reserves the right to reject any Bid and forfeit & appropriate the EMD if:
  - a. at any time, a material misrepresentation is made or uncovered, or
  - b. L1 expresses its desire to or does withdraw its Bid, or
  - c. The bidder does not provide, within the time specified by RailTel, the supplemental information sought by RailTel for evaluation of the Bid within a reasonable time as determined by RailTel in its sole discretion.
- **2.12.3** Such misrepresentation/improper response/intent to withdraw shall lead to the disqualification of the bidder. If the bidder is a consortium, then the entire consortium may be disqualified/rejected.
- 2.12.4 In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the qualification conditions have not been met by the Successful Bidder/Contractor (as may be the case), or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the successful bidder/contractor shall be disqualified forthwith if not yet appointed as the Contractor either by issue of the LOA or entering into of the Agreement, and if the Successful Bidder has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing, by RailTel to the Successful Bidder/Contractor, as the case may be, without RailTel being liable in any manner whatsoever to the Successful Bidder or Contractor. In such an event, RailTel shall be entitled to forfeit and appropriate the EMD or PBG, as the case may be, as Damages,

without prejudice to any other right or remedy that may be available to RailTel under the Bidding Documents and/ or the Agreement, or otherwise.

2.12.5 Bidder are advised to study all instructions, forms, terms, requirements, appendices and other information in the RFP carefully. Online submission of the Bid shall be deemed to have been done after careful study and examination of the RFP with full understanding of its implications and failure to comply with the requirements of the RFP, in addition to submission of all the documents as required hereunder, may render the Bid non-compliant and the same may be rejected

## 2.13 Bid Due Date:

- **2.13.1** Bids should be submitted as per the details mentioned in tender documents/ issued corrigendum in the manner and form as detailed in this RFP.
- **2.13.2** RailTel may, at its sole discretion, extend the Bid Due Date by issuing a corrigendum to this effect uniformly for all Bidders.

## 2.14 Modifications/ Substitution/ Withdrawal of Bids:

The bidder may modify, substitute or withdraw its bid prior to the bid due date. No bid shall be modified, substituted or withdrawn by the bidder on or after the bid due date.

## 2.15 Termination by RailTel:

- **2.15.1** Notwithstanding anything contained herein, RailTel reserves the right to terminate this RFP at any time, without assigning any reasons whatsoever. In this regard, in the event of such termination, RailTel shall not be liable to return the Bid Processing Fees.
- **2.15.2** Further, in the event that the RFP has been terminated on account of any default of the Bidder/Successful Bidder, RailTel reserves the right to encash the EMD and/or PBG to the extent required to make good the losses suffered by it on account of such default having been committed by the Bidder.
- **2.15.3** This RFP does not constitute an offer by RailTel. The Bidder's participation in the Bidding Process may result RailTel selecting the Bidder to engage towards execution of the Scope of Work of the Project.

#### **CHAPTER-III**

## **EVALUATION OF BIDS**

## 3. Evaluation of Bids:

#### 3.1 Evaluation Committee

- 3.1.1 RailTel shall constitute an evaluation committee for evaluation of the Bids, in addition to and including, all the documents submitted by the Bidders in support of/along with their Bids ("Evaluation Committee"). The Evaluation Committee shall evaluate the bids on the basis of the criteria provided under this RFP
- 3.1.2 The decision of the Evaluation Committee shall be final and no correspondences shall be entertained from the Bidder in this regard, except as provided under this Clause.
- 3.1.3 The Evaluation Committee shall be entitled to call for meetings with the Bidders to seek any clarification required in order to examine and evaluate the Bids.
- 3.1.4 The Evaluation Committee reserves the right to reject any or all the Bids on the grounds for rejection as set out under this RFP, including on account of any deviations from the technical, commercial or financial specifications as set out herein.

## 3.2 Opening of Bids:

- 3.2.1 The Bids received form the Bidders shall be opened on due date and time. The opening of the Bids shall be carried out in the physical presence of the designated representatives of RailTel and the Bidders. However, this RFP does not mandate the physical presence of the Bidders. The absence of the physical presence of the Bidders shall in no way affect the outcome of the evaluation of the Bids. During bid opening, only two authorized representative of each bidder shall be allowed to be present.
- **3.2.2** RailTel shall subsequently examine and evaluate the Bids in accordance with the provisions set out in this Chapter.
- **3.2.3** To facilitate evaluation of Bids, RailTel may, at its sole discretion, seek clarifications in writing from any Bidder regarding its Bid.

## 3.3 Test of responsiveness:

**3.3.1** Prior to evaluation of Bids, RailTel shall determine whether each Bid is responsive to the requirements of this RFP. A Bid shall be considered responsive if:

- a. it is received as per the relevant format set out under this RFP.;
- b. it is received by the Bid Due Date including any extension thereof pursuant to the terms of this RFP;
- c. it is accompanied by the EMD as specified in this tender;
- d. it is accompanied by the power(s) of attorney as relevant to a Single Bidder or a Consortium (as may the case be) as per the terms of this RFP;
- e. it contains all the information (complete in all respects) as requested in this RFP and/or Bidding Documents (in formats same as those specified);
- f. it does not contain any condition or qualification limiting or affecting the manner or substance of performance of obligations of the Bidder under this RFP, unless specifically required as per the terms of this RFP;
- g. Provided, if a Bidder imposes conditions, which is in addition to or in conflict with the conditions mentioned herein, its Bid shall be liable to be summarily rejected. In any case none of such conditions will be deemed to have been accepted unless specifically mentioned in the LOA of the Bid issued by RailTel;
- h. It does not contain any suppression of information or facts as required to be furnished by the Bidder under this RFP or as may be relevant to be furnished by the Bidder in relation to the Project;
- i. It does not comprise any incomplete information, subjective / conditional / contingent / partial offers;
- j. is valid for a period of 60 (Sixty days); and
- k. it is not non-responsive as per any other terms of this RFP.
- **3.3.2** RailTel reserves the right to reject any Bid which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by RailTel in respect of such Bid.

#### 3.4 Selection of Bidder:

- **3.4.1** The Evaluation Committee shall prepare a list of responsive Bidders, in accordance with the compliance by such responsive Bidders of the terms and conditions set out under this RFP. All eligible Bids shall be considered for further evaluation by the Evaluation Committee, whose decision in this regard shall be final and binding.
- **3.4.2** Evaluation committee will examine the Bids to determine whether they are complete, whether any computational errors have been made, and whether the Bids are generally in order.

- **3.4.3** The Bids shall be opened in the presence of Bidders'authorized representatives who chose to attend the Bid- opening meeting at their own cost. The Bidders' representatives who are present shall sign a register giving evidence of their attendance.
- **3.4.4** RailTel reserves the right to accept any Bid for the purposes of evaluation and determination of the Successful Bidder, notwithstanding the fact that such Bid may not necessarily be the lowest; and further also reserves the right to reject any Bid without assigning any reasons.

## 3.5 Contact during the bid Evaluation:

Bids shall be deemed to be under consideration immediately after they are opened and until such time RailTel makes official intimation of award/rejection to the Bidders. While the Bids are under consideration, Bidders and/ or their representatives or other interested parties are advised to refrain, save and except as required under the Bidding Documents, from contacting by any means, RailTel and/ or their employees/ representatives on matters related to the Bids under consideration

#### 3.6 Evaluation Process:

**3.6.1** The bids would be evaluated based on quoted price against plans as given in the sample calculation below:

The lowest technically suitable offer will be selected as successful bidder. In case of tie between two lowest offers, the operators having better coverage along the sections (as per information given in Appendix F) will be selected as successful bidder.

**3.6.2** The technical evaluation process may include demonstration of the Mobile Connectivity, reference calls, and site visits to selected customers with comparable configurations.

- **3.6.3** The bidders should submit an undertaking along with their proposed Road map, section wise, along with a definite time frame for further improvement of coverage upto 95% with a continuous dark zone of not more than 500 Mtrs. in each section along the Railway track. In the absence of the above, the bid shall not be considered for evaluation.
- **3.6.4** The bidder shall quote as per details (Price Bid format) indicated in Appendix B.

RailTel may engage 3<sup>rd</sup> Party Audit team for the accessment of quality of service provided by selected Telecom Service Provider on the similar lines as being done by TRAI. Parameters to be measured by the audit team will be defined by RailTel in consultation with Railway Board at the time of audit. Network coverage should be taken across the complete zone.

## 3.7 Contract Management:

On completion of the selection process, RailTel will enter into a contract agreement with the selected bidder(s). The contract entered with RailTel would be operated by RailTel. A Joint Working Order (JWO) on mutually agreed terms would be entered into between RailTel, Railways & the successful bidder. Broadly RailTel's responsibilities would be overall operation of the contract including liasioning with the selected bidder(s) for rate adjustments, matters related to QoS etc. Railway's responsibility would be limited to deal with the successful bidder/their representative(s) for requirement of CUG connections, payment of bills & other day to day matters etc.

The following documents would form part of the agreement between RailTel & the successful bidder: -

- i) This Request for Proposal and all the issued addendum/corrigendum.
- ii) The bidder's proposal in response to this RFP and clarifications made in course of evaluation, including all Appendixes and supporting documents.
- iii) The implementation plan identifying the tasks to be completed, the assigned responsibilities and the scheduled completion dates.

## 3.8 Unsatisfactory Performance:

RailTel shall have the sole and discretionary right to assess performance(s) of the system provided by the bidder and RailTel, without any liability whatsoever, either direct or indirect, may reject the system(s) provided by the bidder, in part or in its entirety, without needing to offer any explanation to the bidder, either during the pre and/or post test period should the same be unsatisfactory and not be to the acceptance of RailTel. The bidder covenants to be bound by the decision of RailTel, without any demure in such an eventuality.

#### 3.9 Award of Contract:

A Letter of Intent (LoI) will be issued in writing by RailTel to the successful bidder(s) on the rates accepted. Once the LoI is accepted by the bidder(s), a letter of Acceptance (LOA)

will be issued and agreement signed with the bidder(s). RailTel shall be the sole judge in the matter of award of contract and the decision of RailTel shall be final and binding. The agreement shall be for a period of Three (3) years with the provision for further extension by one more year.

## 3.10 Cridencial Verification:

- **3.10.1** The tenderer shall submit along with the tender document, documents in support of his/their claim to fulfill the eligibility criteria as mentioned in the tender document. Each page of the copy of documents/ certificates in support of credentials, submitted by the tenderer, shall be self-attested/digitally signed by the tenderer or authorized representative of the tendering firm. Self-attestation shall include signature, stamp and date (on each page). Only those documents which are declared explicitly by the tenderer as "documents supporting the claim of qualifying the laid down eligibility criteria", will be considered for evaluating his/their tender.
- 3.10.2 The tenderer shall submit a notarized affidavit on a non-judicial stamp paper stating that they are not liable to the disqualified and all their statements/documents submitted alongwith bid are true and factual. Standard format of the affidavit to be submitted by the bidder is enclosed as appendix-J. Non-submission of an affidavit by the bidder shall result in summary rejection of his/their bid and it shall be mandatory incumbents upon the tenderer to identify, state and submit the supporting documents duly self-attested by which they/he is qualifying the Qualification Criteria mentioned in the tender document. It will not be obligatory on the part of the RailTel to scrutinize beyond the submitted document of tenderer as far as his qualification for the tender is concerned.
  - a. The RailTel reserves the right to verify all statements, information and documents submitted by the bidder in his tender offer, and the bidder shall, when so required by the RailTel, make available all such information, evidence and documents as may be necessary for such verification. Any such verification or lack of such verification, by the RailTel shall not relieve the bidder of its obligations or liabilities here under nor will it affect any rights of the RailTel thereunder.
  - **b.** In case of any wrong information submitted by the tenderer, the contract shall be terminated, Earnest Money Deposit (EMD), Performance Guarantee (PG) and Security Deposit (SD) of contract forfeited and agency barred for doing business on entire RailTel for 5 (five) years.

#### **CHAPTER-IV**

## FRAUD AND CURRUPT PRACTICES

## 4. Fraud and Currupt Practices:

- **4.1** The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process and subsequent to the issue of the LOA and during the subsistence of the Agreement.
- 4.2 Notwithstanding anything to the contrary contained herein, or in the LOA or the Agreement, RailTel may reject a Bid, withdraw the LOA, or terminate the Agreement, as the case may be, without being liable in any manner whatsoever to the Successful Bidder/Contractor, as the case may be, if it determines that the Successful Bidder/Contractor, as the case may be, has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process. In such an event, RailTel shall be entitled to forfeit and appropriate the EMD or PBG, as the case may be, as Damages, without prejudice to any other right or remedy that may be available to RailTel under the Bidding Documents and/ or the Agreement, or otherwise.
- 4.3 Without prejudice to the rights of RailTel under Clause 4 hereinabove and the rights and remedies which RailTel may have under the LOA or the Agreement, or otherwise if a Bidder/Successful Bidder/Contractor, as the case may be, is found by RailTel to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, or after the issue of the LOA or the execution of the Agreement, such Successful Bidder/Contractor shall not be eligible to participate in any tender or RFP issued by RailTel during a period of 2 (two) years from the date such Bidder/Contractor, as the case may be, is found by RailTel to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practices, as the case may be.
- **4.4** For the purposes of this Clause 4, the following terms shall have the meaning hereinafter respectively assigned to them:
  - 4.4.1 "corrupt practice" means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of RailTel who is or has been associated in any manner, directly or indirectly, with the Bidding Process or the LOA or has dealt with matters concerning the Agreement or arising therefrom, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise

ceases to be in the service of RailTel, shall be deemed to constitute influencing the actions of a person connected with the Bidding Process); or (ii) save and except as permitted under this RFP, engaging in any manner whatsoever, whether during the Bidding Process or after the issue of the LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical adviser of RailTel in relation to any matter concerning the Project;

- **4.4.2** "**fraudulent practice**" means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;
- **4.4.3** "coercive practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person's participation or action in the Bidding Process;
- **4.4.4** "undesirable practice" means (i) establishing contact with any person connected with or employed or engaged by RailTel with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or (ii) having a Conflict of Interest; and
- **4.4.5** "**restrictive practice**" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Bidding Process.

#### **CHAPTER-V**

## GENERAL TERMS AND CONDITIONS

#### 5. General Terms and Conditions:

## **5.1** Time Schedule:

The bidder will be required to supply SIM Cards as per the following schedule:

- 5.1.1 Existing CUG connections: In case of new service provider, all existing CUG numbers shall be ported within 30 days of issue of date of Purchase Order. In case of existing service provider, services as per new contract shall be enabled with in 15 days of issue of LOA.
- 5.1.2 New CUG connections: SIM including enabling of services for new additional CUG connections as per the quantity mentioned in LOA shall be provided within 30 days from the date of placement of Purchase order for the first time. Subsequently, as and when requirement is placed onto the firm, the same shall be provided within three (3) days of placement of order. However, in special circumstances the connection should be provided within 24 hours on Railway's specific request.
- 5.1.3 Order for the CUG connections would be placed by RailTel as per terms & conditions of the contract and the JWO signed between the three parties.
- 5.1.4 Telecom Service Provider shall provide a list of well-defined time frame for various activities like issue of new SIM, activation of various types of services etc. There shall be provision in contract regarding Activation/Deactivation of any type service, only by authorized Railway Representative and Telecom Service Provider shall also send confirmation of activation to the registered email-ID. Incase of multiple violations, maximum 1% penalty of the monthly billed amount for the respective Zone/Divisional HQ/PUs shall be imposed (in addition to penalty of 15% for poor network).

## 5.2 Installation and Acceptance:

The SIM Cards along with the Bill Plan must be supplied & configured in full as per ordered specification. Testing and acceptance will be done at the Railway offices and nodes where the SIM Cards are supplied. Railway's reserve the right to reject the SIM cards if the services are not conforming to the terms in contract agreement. No payment will be made for the rejected SIM cards.

## **5.3** Warranty and Services Availability Penalty:

5.3.1 The bidder is supposed to provide smooth connectivity for voice as well as data services at various locations of Indian Railways in India. The bidder must sign Services Level Agreement (SLA) to provide minimum service availability of 98% at

Zonal Level. To substantiate SLA figure, service provider shall submit a copy of circle wise montly report submitted to TRAI. The bidder must submit detail of any other mechanism and reports that will enable RailTel to monitor the SLA.

- 5.3.2 All the data and voice traffic, arising out of all CUG users, shall be given highest priority QoS.
- 5.3.2 The successful bidder shall also ensure Quality of Service as stipulated by TRAI regulations on Quality of Basic mobile services from time to time, and shall submit quarterly report accordingly, as per the latest TRAI format.

## 5.4 Payment Terms:

Payment for the CUG connection in the Zonal/Divisional HQ/Production units of Indian Railways will be made to the selected bidder at end of each calendar month after enabling the services as per terms & conditions of the JWO signed between all the three parties, on submission of consolidated bill (along with details) to the bill paying unit.

The bills will be dispatched at each of the Railway locations in India as per the JWO. The payment of the bills will be done on monthly basis assuming 30 days in a month and will be adjusted with the next invoice.

Apart from giving the bill in CD, all bills should be made available online to authorized representative at Division/Zone/Board Level for easy access.

## 5.5 Tax:

GST and other Taxes as per extant notifications would be extra as applicable and should not be quoted in the price bid. Successful bidder will generate invoices by taking care of following clauses.

- a. Bidder shall issue a valid tax invoice to concerned Railway Unit/PU's/PSU's cointaining services Recipient GST Number for availing proper credit of CGST/SGST/UTGST/IGST in case of award of contact. GST Amount will not be reimbursed in absence of valid Tax Invoice.
- b. For all the taxable suppliers to be made by the successful bidder, bidder shall furnish all the details of such taxable supplies in the relevant returns to be filed under GST Act.
- c. If the successful bidder failed to comply with any of the above, successful bidder shall pay to buyer/service recipient any expense, interest, penalty as applicable under GST Act.
- d. In case of incorrect reporting of the supply made by the successful bidder in the relevant return, leading to disallowance of Input Credit to buyer/service recipient, bidder shall be liable to pay applicable interest under the GST Act to the credit of

buyer/service recipient. The same provision shall be applicable in case of debit/credit notes.

e. Wherever the law makes it statutory for the Buyer/Service recipient to deduct any amount toward GST at sources, the same will be deducted and remitted to the concerned authority

#### **5.6** Commercial Terms:

- 5.6.1 The successful bidder shall pay a management fees of Rs.120/- per year per connection yearly in advance to RailTel.
- 5.6.2 Any change /modifications (decrease) in the tarrif announced by the TRAI/ Operator in the market for similer services shall also passed to all CUG subscriber of Railway automatically.

#### **5.7** Termination Clause:

If the services are not found satisfactory or any other reason which compels Railways for termination of agreement, either party i.e. RailTel or the bidder can terminate the service agreement by giving three months notice in advance to the other party. In case, the bidder stops service without notice, RailTel has the right to encash the performance Bank Guarantee (PBG). In case the Quality of Service (QoS) is persistently below the agreed upon levels, the contract can be terminated by RailTel by giving 7 days notice in writing.

## 5.8 Settlement of Disputes and Arbitration:

Except where otherwise provided for in the contract, all questions and disputes relating to interpretation and application of the provision of the contract shall be settled mutually within thirty days (30 days only) or such longer period as may be mutually agreed upon from the date that either parties notify in writing that such dispute or disagreement exists. In case the dispute is not settled mutually, these shall be settled by arbitration in accordance with the Arbitration and Conciliation Act, 1996 as amended. The appointment of the arbitrator shall be done by Chairman cum Managing Director, RailTel. The venue of Arbitration shall be New Delhi, India. The arbitration resolution shall be final and binding upon both the parties.

## 5.9 Disclaimer:

This RFP is not an offer by RailTel, but an invitation for bidder response. No contractual obligation whatsoever shall arise from the RFP process until a firm order is placed onto the bidder.

## 5.10 Confidentiality:

This document contains information confidential and propriety to RailTel. Additionally, the bidder will be exposed by virtue of contracted activities to internal business information of RailTel. Disclosure of any part of the aforementioned information to

parties not directly involved in providing the services requested could result in the disqualification of the bidder, pre-mature termination of the contract and/ or legal action against the bidder for breach of trust.

No news release, public announcement, or any other reference to this RFP or any program there under shall be made without written consent from RailTel.

All information regarding this RFP and the current operations, capabilities, products and clients of RailTel which the bidder may learn as a result of preparation of a response to this RFP, or in the course of any ultimate contract negotiation, is propriety and confidential information.

## 5.11 Performance Bank Guarantee (PBG):

The successful bidder shall have to submit a Performance Bank Guarantee (PBG) within 30 days of the issue of Purchase order of Rs. 10 Crore for the satisfactory performance of services covered in RFP. The Bank Guarantee should be valid for a period of 40 (36 +4) Months. Extension of time for submission of BG beyond 30 (thirty) days and up to 60 days from the date of issue of Letter of acceptance may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 15% per annum shall be charged for delay beyond 30 (thirty) days. i.e from 31st day after issue of LOA. In case the contractor fails to submit the requisite PBG even after 60 days from the date of issue of LOA, the contract shall be terminated duly forfeiting EMD and other dues, if any, payable against that contract. The failed contractor shall be debarred from participating in re-tender for that work. Proforma for the Performance Bank Guarantee Bond from a Nationalized Bank is given at Appendix-E.

## **5.12 Service Level Agreement:**

For ensuring the above parameters, bidder shall provide the following reports to M/s RailTel: -

- i. Quarterly Report for Network Uptime and Performance.
- ii. The bidder shall submit a copy of proposed SLA to be signed for reference along with the client list.
- iii. Telecom Service Provider shall provide a list of well-defined time frame for various activities like issue of new SIM, activation of various types of services etc. There shall be provision in contract regarding Activation/Deactivation of any type service, only by authorized Railway Representative and Telecom Service Provider shall also send confirmation of activation to the nominated email-ID. In case of multiple

- violations penality maximum 1% will be deducted from the monthly billed amount in addition to penalty of 15% for poor network.
- iv. Telecom Service Provider shall furnish Telecom Circle wise escalation matrix for the organization along with the Name, Designation and Mobile Number of employees at various level, who shall be responsible for providing the service support. Any change in their organization structure should be intimated to Zonal Railways.

## **5.13 Project Implementation Scheme:**

A detailed project implementation schedule should be provided, clearly mentioning the various stages of implementation and the milestones thereof.

#### **5.14** Liabilities of RailTel:

The RFP is not an offer by RailTel, but an invitation for bidder responses. No contractual obligation whatsoever on behalf of RailTel shall arise from the RFP process unless and until a formal contract is signed and executed by duly authorized officers of RailTel and the bidder(s).

## **5.15 Proposal Process Management:**

RailTel reserves the right to accept, reject any or all proposals, to revise the RFP, to request one or more re-submissions or clarifications from one or more bidders, or to cancel the process in part or whole. Each party shall be entirely responsible for its own costs and expenses incurred while participating in the RFP and subsequent presentations, demonstrations and trials, and contract negotiation process.

## 5.16 Authorization to Bid:

Responses submitted by a bidder to this RFP represent a firm offer to enter in to a contract on the terms and conditions described in the RFP. The proposal must be signed by an official authorized to commit the bidder to the terms and conditions of the proposal. Bidder must clearly identify the full title and authorization of the designated official and provide a statement of offer commitment with the accompanying signature of the official and submit the copy of power of attorney/authority letter authorizing the signatory to sign the bid.

## 5.17 Intellectual property:

The proposal and all supporting documents submitted by the bidder shall not be returned and shall be retained by RailTel. RailTel will however not disclose any confidential information in these documents.

## **5.18 Delivery and Installation:**

The bidder shall be responsible for delivery of the requisite SIM Cards including installation and commissioning of cards at the respective locations as specified in the

purchase order and for making them fully operational at no additional charge within the time period as specified in tender or the duration committed by the bidder, whichever is earlier.

If the bidder fails to deliver and/or install the requisite equipments ordered within the stipulated time schedule or by the date as extended by RailTel, it will be construed as a breach of contract and suitable liquidated damages will be levied as per tender.

## 5.19 Liquidated Damages and Penalty:

- a. If there is any delay in the implementation of the system due to bidder's fault from schedule furnished by the bidder and accepted by RailTel, RailTel/ Railway will recover 0.5% of the value of the Purchase Order from the bidder for each week of delay. The recovery will be subject to an upper limit of 10%.

- i. RailTel reserves the right to order any number of Mobile (cellular) Connections as may be required at the time of work order and increase or decrease subsequently by giving 15 (Fifteen) days notice.
- ii. Number of subscriber in each slab should be taken (+/-) 30% of the projected numbers. For any variation beyond (+) 30%, fresh price negotiation must be carried out, with Telecom Service Provider (TSP).
- **5.22** Due preference shall be given to Public Sector Undertakings of Government of India as per extant rules applicable on the day of tender opening.

#### **CHAPTER-VI**

#### OTHER GENERAL TERMS AND CONDITIONS

## **6** Other General Terms and Conditions:

#### **6.1 Powers of RailTel:**

RailTel, at its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;

- 6.1.1 Suspend and /or cancel the Bidding Process and/or amend and/or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
- 6.1.2 Consult with any Bidder in order to receive clarification or further information.
- 6.1.3 Retain any information and/or evidence submitted to RailTel by, on behalf of, /or in relation to any Bidder, and/or
- 6.1.4 Independently verify, disqualify, reject and/or accept any and all submission or other information and/or evidence submitted by or on behalf of any Bidder.

## 6.2 Bidder's Undertaking:

It shall be deemed that by submitting the Bid, the Bidder agrees and releases RailTel, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/or performance of any obligations hereunder, pursuant hereto and/or in connection with the Bidding Process and waives, to the fullest extent permitted by Applicable Laws, any and all rights and/or claims it may have in this respect, whether actual or contingent, whether present or in future

## **6.3** Overriding Effect:

Notwithstanding anything to the contrary contained in this RFP (including the Appendix), and without prejudice to the obligations of the Bidder set out in detail herein (which shall apply in addition to the obligations set out under the Agreement), in the event of a conflict, the detailed terms specified in the Agreement shall have overriding effect over the terms provided hereunder.

## 6.4 Non-Responsiveness of the Bid:

RailTel shall be fully empowered and reserves the right to decide in its sole discretion, to reject any bid on grounds of the same being non-responsive due to existence of any condition, qualification or any other contained therein.

The Bid and all communications in relation to or concerning the Bidding Documents and the Bid shall be in English language. If any supporting documents submitted are in any

language other than English, translated copies of the same to English language, along with the certification of the translated documents for its genuineness, accuracy and authenticity of the document, shall be attested along with such original documents by the Bidder (and such translated copy shall govern in the event of any conflict between the documents).

## **6.5** Full Documents:

The Bidder shall ensure that all the documents as required under this RFP for evidencing inter-alia its technical capabilities and eligibility requirements, are submitted by it in full and are not redacted or suppressed in any manner except as required pursuant to the Applicable Law (in which case the Bidder shall intimate RailTel to this effect in writing before submission of the Bid).

## 6.6 RFP – RailTel Property:

This RFP and all other documents attached/annexed/appended/provided herewith, are provided by RailTel and shall remain (or become upon their coming into existence) the property of RailTel and are transmitted to the Bidders solely for preparation and the submission of a Bid in accordance herewith.

## 6.7 Cost of Bidding:

The Bidders shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bidding Process. RailTel with not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

## 6.8 Rejection of Bids:

- 6.8.1 Notwithstanding anything contained in this RFP, RailTel reserves the right to reject any Bid and to annul the Bidding Process and reject all Bids at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefor. In the event that RailTel rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder:
- 6.8.2 RailTel reserves the right not to proceed with the Bidding Process at any time, without notice or liability, and to reject any Bid without assigning any reasons.
- 6.8.3 Bids received by RailTel after the specified time on the Bid Due Date shall not be opened and returned as it is.

## 6.9 Correspondence with Bidder:

RailTel shall not entertain any correspondence with any bidder in relation to acceptance or rejection of any bid.

## 6.10 Bidder's Due Diligence:

The Bidder shall be expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all information required in the Bidding Documents or submitting a Bid not substantially responsive to the Bidding Documents in any respect may result in the rejection of the Bid.

## 6.11 Annulment and Re-award:

Failure of the Successful Bidder to comply with all the requirement shall constitute sufficient grounds for the annulment of the award of the Agrreement, in which event RailTel may make the award to the next lowest evaluated Bidder or calls for fresh bid's.

The information in the Comparison Chart is based on the data submitted by the Bidders in electronic forms. A detailed Technical and/ or Financial Comparison Chart enhance Transparency. Detailed instructions are given on relevant screens.

ETS has a unique facility of a detailed report titled 'Minutes of Online Tender Opening Event (TOE)' covering all important activities of 'Online Tender Opening Event (TOE)'. This is available to all participating bidders for 'Viewing/ Downloading'.

There are many more facilities and features on ETS. For a particular tender, the screens viewed by a Supplier will depend upon the options selected by the concerned Buyer.

NOTE: In case of internet related problem at a bidder's end, especially during 'critical events' such as - a short period before bid-submission deadline, during online public tender opening event, during e-auction, it is the bidder's responsibility to have backup internet connections.

In case there is a problem at the e-procurement/ e-auction service-provider's end (in the server, leased line, etc) due to which all the bidders face a problem during critical events, and this is brought to the notice of RailTel by the bidders in time, then RailTel will promptly reschedule the affected event(s).

#### 10. Other Instructions

For further instructions, the vendor should visit the home-page of the portal (https://www.tcil-india-electronictender.com), and go to the User-Guidance Center.

The help information provided through 'ETS User-Guidance Centre' is available in three categories - Users intending to Register / First-Time Users, Logged-in users of Buyer organizations, and Logged-in users of Supplier organizations. Various links are provided under each of the three categories.

**Not**e: It is strongly recommended that all authorized users of Supplier organizations should thoroughly peruse the information provided under the relevant links, and take appropriate action. This will prevent hiccups, and minimize teething problems during the use of ETS.

### 11. The following KEY INSTRUCTIONS for BIDDERS' must be assiduously adhered to:

1. Obtain individual Digital Signing Certificate (DSC or DC) well in advance of your first tender submission deadline on ETS.

- 2. Register your organization on ETS well in advance of your first tender submission deadline on ETS.
- 3. While registering your organization on ETS Portal of TCIL, pl. make sure that the email id of Super user provided for registration and email-id on which Digital Signature Certificate of the Super user is issued are exactly the same.
- 4. Get your organization's concerned executives trained on ETS well in advance of your first tender submission deadline on ETS.
- 5. Bidder should ensure that **official copy of tender document** has been downloaded by clicking the radio button for confirmation else e-Procurement system will not permit the bidder to participate in the tendering process.
- 6. Submit your bids well in advance of tender submission deadline on ETS as there could be last minute problems due to internet timeout, breakdown, etc.

However, if a vendor has not already attended ETS Vendor Training earlier, it is highly recommended that the vendor attends this training positively to be able to submit the e-Tender smoothly without any problem.

Vendors are requested to carry a Laptop and Wireless Connectivity to Internet while attending the ETS Vendor Training.
