### Additional Clause added to EOI

- 1. Bidders, along with this offer, to submit Preliminary Project Report (PPR) duly adhering to Para:44, Pg:22 and as per **Appendix D** of MOD's DCG RFP covering the scope of this EOI.
- 2. For an equipment to be introduced in service, it is mandatory that it successfully clears all stipulated tests/ trials/ evaluations as per RFP. The trial evaluation process is placed at **Appendix 'G'** of MOD's DCG RFP.
- 3. Bidders, along with this offer, to submit the documents mentioned at Para:258, Pg:397 of MOD's DCG RFP".
- 4. Bidders, need to comply to the commercials clauses mentioned at **Appendix H** at Pg:442 to 447 of MOD's DCG RFP.
- 5. **Option Clause:** Bidder must comply to the option clause for procurement of hardware & ERP licenses. The format of option clause is placed at **Appendix L** at Pg:485 of MOD's DCG RFP.
- 6. Bidders, along with the bid documents need to submit signed copy of this EoI and all the corrigendum/addendum issued from time to time.
- 7. Bidders, need to comply to standard conditions of RFP mentioned at **Appendix K** at Pg:469 to 474 of MOD's DCG RFP All the references of RFP mentioned in this EoI, should be read in conjunction with subsequent Pre-bid Clarifications, corrigenda, Addenda issued from time to time by MoD/ICG for DCG Project.
- 8. Liquidated Damages (LD): In the event of the Bidder's failure to submit the Documents, supply the stores/ goods, perform services, conduct trials, installation of equipment, training and MET as per schedule specified in this contract, the BUYER may, at his discretion withhold cost of the specific lot/batch or 1% of the Project cost, whichever is higher, until the completion of the contract. The BUYER may also deduct from the SELLER as agreed, liquidated damages to the sum of 1/100 of the delay percentage {Delay percentage = (Period of Delay in Delivery in Weeks) x 100 / (Delivery Period in weeks as per contract)} of the Base Contract Price of the delayed/ undelivered stores/ services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages being not higher than 10% of the contract price of the value of delayed stores/ services (Any extension given by the Buyer for delay attributable to Buyer or Force Majeure Clause to be factored in delivery period).
