(RailTel), Eastern Region on behalf of East Central Railway invites Open e- Bids in two packet single stage system from established contractors with proven experience for the work of "Shifting of underground Optical Fibre Cable in Sarai - Hajipur Section of East Central Railway by trenching, laying of HDPE duct, backfilling, blowing/pulling, Splicing/jointing & testing of OFC with associated work for RailTel Corporation of India Limited, Eastern Region."
