
#### 1. About RailTel:

#### 1.1. Introduction:

RailTel Corporation of India Ltd (RailTel) is one of the largest neutral telecom infrastructure providers in the country owning a Pan-India optic fiber network on exclusive Right of Way (ROW) along Railway track. The OFC network presently reaches to over 4500 towns & cities of the country including several rural areas. With its Pan India high capacity network, RailTel is working towards creating a knowledge society at various fronts. During the recent years, RailTel has provided Wi-Fi service at more than 5,700 stations in country and is extending the same to Rural stations. The portfolio of services provided by RailTel includes Data center & DR services, Tele- presence as a service, NLD services, IP-1 services, Internet and Broadband services on a Pan-India basis.


Equipped with an ISO 9001, 20000-1:2011 & 27000 certifications, RailTel offers a wide gamut of managed telecom services to Indian Telecom market including Managed lease lines, Tower colocation MPLS based IP-VPN, Internet, Data Center services, NGN based voice carriage services to Telecom Operators, Dark fiber leasing to MSOs/LCOs. The major customer segment for RailTel comprises of Enterprises, Banks, Government Institutions/ department, Educational Institutions/ Universities, Telecom Service Providers. Internet Service Providers, MSOs, etc. RailTel being a "Mini Ratna (Category-I)" PSU is steaming ahead in the enterprise segment with the launch of various services coupled with capacity augmentation in its Core network. Your company stands as the only telecom PSU, which is a 100% debt free company and consistently profit-making PSU in telecom sector.

A look at the past 5 years performance reveals RailTel's healthy growth, as it realizes returns from its existing services and marks its foray into the Enterprise IT space. RailTel's growth rate is expected to accelerate further as it ventures into providing more value-added Enterprise IT services. This bodes well for RailTel as the growth of RailTel is comparable to the average growth rate of the top three domestic neutral telecom players in India which is ~12 percent.

#### 1.2. Network Strength:

RailTel has exclusive seamless Right of Way (ROW) along 67,368 KM of Railway Track passing through 7349 stations across the country. Using this ROW, RailTel has so far laid 50251 RKMs of OFC and OFC lit is 48243 RKMs till March 31, 2019. Works on another 3698 KMs are in various stage of execution. RailTel's high speed OFC Backbone Network shall ultimately cover the entire railway route across the country. In high bandwidth backbone segment, RailTel occupies a proud place with its unparalled network. The network has the ability to provide mission critical customized connectivity platform for enhanced corporate efficiency and growth.

RailTel is creating PoPs at every Railway station en route which are spaced at 8-10 Kms. At all the stations en route is deployed STM-1/4 (155/625 Mbps) primarily to meet Railways requirement. The distribution layer network of STM-64/16 (10G/2.5G) spaced at 40-60 KMs is deployed to connect important towns/cities of the country. Presently this network is available at over 600 cities in multiple rings of STM-64/16. Further, RailTel has also provided n x 10G capacities on its Core network using DWDM at over 25500 RKM across 85 cities to provide Giga capacities capable to provide up to 400/800G.

RailTel has recently upgraded the Mumbai-Chennai DWDM path on 100G capacity on single channel making it one of the few operators in the country to have such network. On similar lines, other important metro routes are also under the process of bandwidth up gradation. On top of this network, RailTel has upgraded its MPLS network to provide n x 10G capacities on backbone with access routers having multiple of 2.5G/1G capacity. Access network with C/DWDM, STM-64/PTN is being provided in important cities to meet further connectivity requirements.

#### 1.3. Vision of RailWire Services

Digital infrastructure and services are increasingly emerging as key enablers and critical determinants of a country's growth and well-being. With significant capabilities in both telecommunications and software, India, more than most countries, stands poised to benefit from harnessing new digital technologies and platforms to unlock productivity, as well as to reach unserved and underserved markets; thus, catalyzing economic growth and development, generating new- age jobs and livelihoods, and ensuring access to next generation services for its citizens.

Broadband has become a key priority of the 21st Century and has the transformative power as an enabler for economic and social growth by making it an essential tool for empowering people, creating an environment that nurtures technological and service innovation, and triggering positive change in business processes as well as in society as a whole. It has been broadly estimated that a 10% increase in broadband penetration in a country could potentially lead to an over 1% increase in GDP. However, studies in India estimate that the impact could be significantly higher for the country, given the increased productivity and efficiency gains that are likely to accrue to the economy.

#### 1.4. RailWire

RailWire is a retail Broadband initiative of RailTel, with a mission to make available "ICT to Common Man" & "Internet, Education and Health Services to the Masses". RailTel envisaged extending broadband and application services to the public including those in remote areas in association with Local Cable Operators and other access network providers, by utilizing their last mile. Managed Service Partners (MSPs) provide customer support, partner support, evangelize and market RailWire services on behalf of RailTel on a revenue sharing basis. RailWire, by focusing on pure-play broadband and VPN services, aims to become a hub of local information, and a platform for rendering communication, infotainment, education, health and community services to the masses.

RailWire retail broadband is currently serving more than 2,50,000 home-users in 24 Circles across India.

Since the network has no legacy baggage, symmetrical high-speed broadband service with capabilities of content delivery can be rolled out. Entertainment, Education and Health will be primary verticals to be rolled out in the Content Delivery Network. Since the rollout will harness the entrepreneurial energies of thousands of network operators and as many MSPs as required, this model can scale and spread very fast to achieve the broadband penetration targeted by the government.

This process is open to all applicants who fulfil the eligibility criteria as set out in **Annexure-**'A' of this document. Applicants should furnish information on the lines of Annexure-A in their RFQ proposal.

The scope of work includes marketing, survey, design, supply, installation, testing commissioning and Operation & Maintenance of Triple play services.

Before full scale launch of service, it is proposed that RailTel and selected partner(s) can have a soft launch as proof of concept (POC).

#### **POC Scope of work:**

The scope of work is to deploy 5000 triple play connections in two phases.

Phase 1: 250 connections POC in each zone at the locations mentioned at point (1) below, with STBs to be supplied by Triple play partner and reimbursed by RailTel, to market the RailWire Triple play brand

The allocation of locations under Phase-1 PoC will be equally distributed among the empaneled partners in each zone. The objective of Phase-1 PoC is to check the technical competences of empaneled partners and to test the quality of services, deliverables as per expectations and market acceptance. In this phase, the empaneled partners have to provide the services along with STBs at a competitive rate.

Phase 2: 2250 connections POC in each zone, with STBs to be supplied by Triple play partner charged to the subscriber on EMI basis and may be distributed through RailWire MSPs & Partners.

Price discovery from the empaneled partners for the entire package inclusive of hardware, software and content will be considered on the basis of their performance in phase-1, to build a joint business model to test the market with various plans & commercial models in Phase 2.

The following is the detailed scope:

The empaneled partner(s) needs to deliver IPTV services and OTT Services to its subscribers in one or more of 7 locations viz Delhi (NCR), Mumbai, Bangalore, Chennai, Hyderabad, Kolkata & Ahmedabad.

RailTel broadband infrastructure will take care of the required Internet connectivity from the empaneled Vendor's IPTV & OTT headend location to the required destinations in a Unicast mode.

#### 5. Hardware Models:

#### 6. Service SLAs

- Required Hardware, Content and Software to deliver these services need to be provided by the bidder
- Content relationships & compliance is the responsibility of the bidder
- The entire software and hardware need to be maintained for 6 Months as part of the POC and the further period will be decided on course.
- During POC period

#### **Service Delivery Locations:**

The service should be available in above locations chosen by RailTel. While RailTel will ensure the connectivity, the empaneled vendor needs to ensure the delivery of services using RailTel broadband infrastructure.

#### **Field Deployment of Android STBs:**

The Android STB to be installed at subscriber by RailTel MSPs/LCOs. Empaneled Vendor to train the RailTel staff and MSPs/LCOs on the Installation process and last mile requirement.

#### Regulation:

The IPTV deployment should adhere to Schedule 3 regulation laid out by TRAI. Vendor has to take responsibility of delivering IPTV services according to the regulations.

RailTel will seek commercial quote from the empaneled partners for the POC and will invest in Phase 1 of the POC to encourage ANPs and gain confidence in the service.

#### iii. Extension of date of submission of RFQ:

Request for extension of date for submission of RFQ will not be entertained. However, RailTel at its discretion may extend the deadline in order to allow prospective applicants a reasonable time to take the amendment/changes, if any, into account.

#### 6 Process of bidding:

#### 6.1 Response to RFQ

The response to RFQ should be submitted on or before 15:00 hours on 16-11-2020 through "ONLINE" mode on e-Tender portal <a href="https://railtel.enivida.com">https://railtel.enivida.com</a>, which will be opened on 16-10-2020 at 15:30 hours in front of representatives of bidders.

Separate responses for each zone shall be submitted online and the response should also include detailed compliance/ non-compliance of requirements listed in RFQ.

In this case, the registration fee paid for e-Nivida portal is valid for one year from the date of payment and will be valid for all the online bids that the bidder may participate during the year. However, RFP/RFQ processing fee is to be paid separately for each of the online bid.

#### 6.2 e-Tendering Portal

e-Tendering is a new methodology for conducting Public Procurement in a transparent and secured manner. Now, the Government of India has made e-tendering mandatory. Suppliers/ Vendors will be the biggest beneficiaries of this new system of procurement. For conducting electronic tendering, RailTel has decided to use the portal <a href="https://railtel.enivida.com">https://railtel.enivida.com</a>.

#### 6.3 Tender Bidding Methodology

Online Bid System - 'Single Stage': In this, bidder has to submit the bid through "ONLINE" mode. If the bidder is applying for more than one zone, then bidder need to submit separate online bids for each zone.

NOTE: In case of internet related problem at a bidder's end, especially during 'critical events' such as - a short period before bid-submission deadline, during online public tender opening event, during e-auction, it is the bidder's responsibility to have backup internet connections.

#### 6.8 Earnest Money Deposit (EMD) and Cost of RFQ document

#### (a) Earnest Money Deposit (EMD):

The bidder has to submit the EMD of Rs. 2,00,000/- (Rs. Two Lakh only) per zone payable online at https://railtel.enivida.com

The successful bidder's EMD shall be returned on receipt of valid & authenticated Performance Bank Guarantee (PBG) that is to be submitted as per clause 13.3.

The unsuccessful bidder's EMD will be discharged / returned after signing of the contract with the successful Bidder. No interest will be paid by RailTel on the EMD amount.

#### The EMD may be forfeited:

#### 8.0. Process after submission of RFQ:

- i. All responses to this RFQ received by the designated date and time will be examined by RailTel to determine if they meet criteria/terms and conditions mentioned in this document including its subsequent amendment(s), if any, and whether responses are complete in all respect.
- ii. During evaluation, if any of the information/data submitted by the bidder is not in desired format / illegible / incomplete / not containing clear information, then at its sole discretion, RailTel can solicit the required information/data from the bidder. If the bidder fails to fulfil the requirement, then such bids will be rejected from further evaluation process.

- iii. If deemed necessary, RailTel may seek clarifications on any aspect of RFQ from the bidder. If a written response is requested, it must be provided within stipulated timelines. RailTel may also make enquiries to establish the past performance of the applicants in respect to document submitted by bidder. All information submitted in the application or obtained subsequently will be treated as confidential.
- iv. As a part of mandatory requirement of this RFQ, bidders are required to make presentation of their proposed methodology, capabilities, proposed business model and demonstrate proof of concept.

- **9.4** Any effort on the part of applicant to influence evaluation process may result in rejection of the RFQ.
- **9.5** RailTel is not responsible for non-receipt of response to this RFQ within the specified date and time due to any reason including postal delays or holidays in between.
- 9.6 RailTel reserves the right to verify the validity of information provided in the response to RFQ and to reject any bid where the contents appear to be incorrect, inaccurate or

inappropriate at any time during the process of RFQ evaluation or even after award of contract.

- **9.7** Applicants shall be deemed to have:
  - a) examined the RFQ document and its subsequent changes, if any for the purpose of responding to it.
  - b) examined all circumstances and contingencies, having an effect on their RFQ application and which is obtainable by making of reasonable enquiries, satisfied themselves as to the correctness and sufficiency of their RFQ applications and if any discrepancy, error or omission is noticed in the RFQ, the applicant shall submit such notification to RailTel in writing on or before the end date/time
- **9.8** The applicant shall bear all costs associated with submission of RFQ, presentation/POC desired by RailTel. RailTel will not be responsible or liable for any cost thereof, regardless of the conduct or outcome of the process.
- 9.9 Applicants must advise RailTel immediately in writing of any material change to the information contained in the RFQ application, including any substantial change in their ownership or their financial or technical capacity. Copies of relevant documents must be submitted with their advices. Shortlisted applicants must not advertise or publish the same in any form without the prior written consent of RailTel.
- 9.10 The empanelment agreement placed at Annexure-G will be signed with each qualified bidder within 1 month from the date if acceptance of LOE. The service level agreement having more details like Price discovery, Marketing Strategy, Revenue Share will be signed with the successful partner in the price discovery process of phase-2 of the POC.
- 9.11 In case, RailTel participates in any of the tenders for triple play services, in association with the empaneled partner upon agreement on the terms and conditions mentioned in the tenders, and wins such tenders, then the empaneled partner will have to comply to all the terms and conditions mentioned in such tenders. Conditions such as, but not limited to, submission of PBG, payment terms, penalties etc with respect to those tenders will be on back to back basis with the empaneled partner.
- 9.12 In case for a zone, the empaneled bidder shows unwillingness to participate in any tender along with RailTel, then RailTel may participate in such tenders along with second top scored bidder of the same zone. In case, if there is no other bidder in the said zone or if the second top scored bidder of said zone shows unwillingness, then RailTel may consider the empaneled bidders of other zone to participate in such tenders based on the network capability and willingness of such bidders.

- **9.13** In case, after participation in tenders and getting the work awarded, the selected bidder fails to comply the tender conditions, then RailTel may consider other empaneled bidders as per the hierarchy mentioned in above clause 9.12.
- **9.14** RailTel shall have the right to cancel the RFQ process itself at any time, without thereby incurring any liabilities to the affected applicants. Reasons for cancellation, as determined by RailTel in its sole discretion include but are not limited to, the following:
  - a) Services contemplated are no longer required to RailTel.
  - **b)** Scope of work not adequately or clearly defined due to unforeseen circumstance and/or factors and/or new developments.
  - c) Any other reason which RailTel may deem fit.
- **9.15** Bidder shall comply to all the laws of land in providing the services after getting empaneled as Triple Play Service partner of RailTel as a result of this RFQ.

#### 10 PLACEMENT OF EMPANELMENT:

- i. RailTel shall consider placement of offer for empanelment only on those eligible bidders whose offers have been found technically suitable.
- ii. All submitted offers shall be evaluated and offers of those bidders who meet the pre-eligibility criteria, achieved minimum score of 75% in technical evaluation shall be empaneled by RailTel for Triple play services. Since this is an empanelment, RailTel reserves the right to empanel any or all the participants eligible.
- iii. Bidders can apply for one or more zones and will be evaluated separately for each zone as per the criteria. The names of states constituting zones are provided at Annexure -J.
- iv. Depending on the response and the alignment of response to RailTel's goals, RailTel may empanel any or all the eligible partners separately for the below mentioned zones:
  - (a) Zone 1 Southern Region and Eastern Region
  - (b) Zone 2 Northern Region and Western Region

However, RailTel has the discretion to make further zones or reserves the right to appropriately demarcate its zones to meet business objectives.

- v. Bidders should meet the eligibility criteria separately for each zone and the eligibility will be considered cumulative of each eligibility criteria, if bidder is applying for more than one zone.
- vi. In case, more than one bidder is empaneled for any zone, preference will be given to the top scorer among them. RailTel at its discretion may also decide to distribute the services within the zone based on the network capability of the empaneled bidder.

vii. Bidders need to give their preference for the zone on bidder's letter head, if bidder is applying for more than one zone.

#### 11 NOTIFICATION OF EMPANELMENT:

- i. The issue of empanelment order shall constitute the intention of RailTel to enter into Contract with one or more bidders for each zone. Empanelment order will be issued separately for each zone.
- **ii.** Within a maximum of 7 days from the date of issue of the Letter of Empanelment (LOE), the Partner shall submit the acceptance of LOE.
- Empaneled partner needs to setup the required infrastructure for delivering the triple play services within 2 months from the date of acceptance of LOE.

#### 12 SIGNING OF THE AGREEMENT:

- 12.1 Empaneled partners need to sign an empanelment agreement with RailTel within one month from the date of acceptance of LOE. The agreement with the empaneled partner will be signed separately for each zone. Agreement will be signed only after submission of Performance Bank Guarantee (PBG) by the empaneled partner for each zone. Empaneled partner needs to set up the required infrastructure for delivering the triple play services within 2 (two) months from the date of acceptance of LOE. The agreement will be valid for the duration of five (5) years from the date of signing of agreement and extendable by 2 (two) years mutually decided by RailTel and Empaneled partner.
- 12.2 After the execution of empanelment agreement, RailTel and the successful bidder will execute service level agreement on mutually agreed terms and conditions. The SLA clauses will be defined in service level agreement signed b/w RailTel and empaneled partners.
  - 12.3 Upon the successful bidder furnishing PBG, RailTel shall return the EMD submitted by the firm. No interest will be payable on the submitted EMD amount.

#### 13 OTHER GENERAL TERMS & CONDITIONS OF THE RFQ:

#### **13.1 PATENT RIGHTS:**

The Partner shall indemnify RailTel against all third-party claims/actions of infringement of patent, trademark or industrial design rights arising from use of the goods or any part thereof inservice delivery by the partner.

#### 13.2 INDEMNITY:

The partner shall indemnify, defend and hold RailTel harmless from and against any losses, costs, expenses, damages of whatsoever nature which may be incurred or suffered by RailTel which

arises out of or as a result from any breach of contract, warranty, tort (including negligence) or otherwise of partner's obligation or agreement contained herein.

#### 13.3 Performance Bank Guarantee (PBG)

- 13.3.1 The value of PBG of this RFQ is Rs 6 Lakh per zone. The successful bidder shall arrange for the BG in favor of M/s RailTel Corporation of India Ltd payable at New Delhi within the timelines stipulated and the EMD shall be returned by RailTel and the validity of PBG will be for 5 (Five) years and extendable by 2 (two) more years.
- 13.3.2 Failure of the successful bidder to comply with the requirement as per the RFQ terms and conditions shall constitute sufficient grounds for the annulment of the award and forfeiture of the PBG, in such event RailTel may make the award to the second top ranked bidder or call for new bids.
- 13.3.3 If the bidder is terminated as per the clauses 13.7 and 13.8, then bidder shall have to forfeit the Performance Bank Guarantee.
- 13.3.4 Empaneled partners need to submit separate PBG for each zone.

#### **13.4 PAYMENT TERMS:**

- 13.4.1 RailTel and the partner will evolve appropriate settlement terms. It is envisaged that the payments would be settled monthly. But, however, any other models more suitable for the business can be adopted jointly.
- 13.4.2 In case of participation in tenders by RailTel and partner jointly, the Payments due to the partner will be on back to back basis based on the terms and conditions stated in the tenders. In such cases, bidder will have to submit PBG on back to back basis or as per prevailing in RailTel.

#### 13.5 PRICING TERMS:

- 13.5.1 In case of services provided to RailTel's broadband subscribers, the Go-to Market Strategy and pricing of services will be done jointly by RailTel and the empaneled partner. RailTel shall raise the invoice for all the services comprising of triple play and any other service that would be provided to its customer.
- 13.5.2 In case of participation in tenders by RailTel and partner jointly, the prices to be quoted in the tenders will be decided jointly by RailTel and partner.

#### **13.6 FORCE MAJEURE:**

- 13.6.1 If at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligations under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restriction, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by the either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this and contract shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of RailTel as to whether the deliveries have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at its option terminate the contract.
- 13.6.2 Provided also that if the contract is terminated under this clause, RailTel shall be at liberty to take over from the partner at a price to be fixed by the Purchaser, which shall be final, all unused, undamaged and acceptable materials, bought out components and stores in course of manufacturer in possession of the partner at the time of such termination of such portions thereof as the purchaser may deem fit excepting such materials / bought out components and stores as the contractor may with concurrence of the purchaser elect to retain.

#### 13.7 TERMINATION FOR DEFAULT:

Any of the following events shall constitute an event of default by the Bidder entitling the Competent Authority to terminate the concessions granted to the Bidder:

- 13.7.1 RailTel may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the partner, terminate this contract in whole or in part.
- **13.7.1.1** If the partner fails to deliver any or all of the goods/services within the time period(s) specified in the Contract/ service level agreement, or any extension thereof granted by RailTel.
- 13.7.1.2 If the partner fails to perform any obligation(s) under the Contract; and
- **13.7.1.3** If the partner, in either of the above circumstances, does not remedy his failure within a period of 30 days (or such longer period as RailTel may authorize in writing) after receipt of the default notice from RailTel.
  - **13.7.2** Upon occurrence of any of the defaults, RailTel would follow the procedures of issuing time bound Notice/Show Cause before deciding on termination of the agreement. The decision of RailTel shall be final and binding on the Bidder.

**13.7.3** The contract shall not be terminated for failure to discharge responsibilities due to force majeure situations or failure by RailTel to meet conditions precedent.

#### 13.8 TERMINATION FOR INSOLVENCY:

RailTel may at any time terminate the contract by giving written notice to the partner, without compensation to the partner, if the partner becomes unwilling, bankrupt or otherwise insolvent.

#### 13.9 GOOD FAITH NEGOTIATION:

- **13.9.1** The parties shall endeavor, in the first instance to resolve any dispute, disagreement arising out of or in connection with this agreement through Good Faith and Negotiation.
- 13.9.2 For the purpose of conducting Good Faith Negotiations, each party shall within 15 days of the commencement of the agreement designate in writing to the other party a representative who shall be authorized to negotiate on its behalf with a view to resolve any dispute. Each such representative shall remain so authorized until his replacement has been designated in writing to the other party by the part he represents.
- **13.9.3** The dispute shall not be referred to Arbitration unless and until the provisions of this clause have been complied with.
- 13.9.4 The representative of the party which considers that a dispute has arisen shall give to the representative of the other party, a written notice setting out the material particulars of the Dispute in issue, in short, a Dispute Notice shall be served upon by the representative of the party which considers that a dispute has arisen to the representative of the other party.
- 13.9.5 Within 30 days or such longer period as may be mutually agreed to, of the Dispute Notice, having been delivered to the other party, the representatives of both parties shall meet in person at either of the registered office of the parties or at any designated place to attempt in good faith, and using their cost endeavors at all times to resolve the dispute. Once the dispute is resolved, the terms of the settlement shall be reduced in writing and signed by the Representatives of the parties (the settlement).
- **13.9.6** If a settlement is not reached within thirty days after Negotiation on date, such dispute shall be referred to Arbitration.

#### 13.10 ARBITRATION:

**13.10.1** The parties shall, at the first instance, attempt to resolve through good faith negotiation and consultation, any difference, conflict or question arising between the parties hereto relating to or concerning or arising out of or in connection with this agreement, and such negotiation

or consultation shall begin promptly after a Party has delivered to another Party a written request for such consultation.

- **13.10.2** In the event of any dispute, difference, conflict or question arising between the parties hereto, relating to or concerning or arising out of or in connection with this agreement, is not settled through good faith negotiation or consultation, the same shall be referred to arbitration by a sole arbitrator.
- 13.10.3 The sole arbitrator shall be appointed by CMD/RailTel out of the panel of independent arbitrators maintained by RailTel, having expertise in their respective domains. The seat and the venue of arbitration shall be New Delhi. The arbitration proceedings shall be in accordance with the provision of the Arbitration and Conciliation Act 1996 and any other statutory amendments or modifications thereof. The decision of arbitrator shall be final and binding on both parties. The arbitration proceedings shall be conducted in English Language. The fees and cost of arbitration shall be borne equally between the parties. "

#### 13.11 Disclaimer:

RailTel is not committed either contractually or in any other way to the applicants whose applications are accepted. The issue of this Request for Qualification does not commit or otherwise oblige the RailTel to proceed with any part or steps of the process. Subject to the applicable legal provisions, RailTel and its directors /officers /employees /contractors /agents and advisors disclaim all liabilities (including liability by reason of negligence) from any loss or damage, cost or expense incurred or arising by reasons of any person using the information and whether caused by reasons of any error, omission or misrepresentation in the information contained in this document or suffered by any person acting or refraining from acting because of any information contained in this Request for Qualification document or conduct ancillary to it whether or not the loss or damage arises in connection with any omission, default, lack of care or misrepresentation on the part of RailTel or any of its officers, employees, contractors, agents or advisors
