(RailTel), Eastern Region on behalf of North East Frontier Railway invites Open e- Bids in two packet single stage system from established contractors with proven experience for the work of "Rectification of underground Optical fibre cable in Arunachal – Sribar - Vangaichungpao Section of North East Frontier Railway including trenching, laying of HDPE duct, backfilling, blowing/pulling, Splicing/jointing, termination & testing of OFC with associated work for RailTel Corporation of India Limited, Eastern Region"
