1	Section-I, Chapter-III	As we understand, if switch don't support 4KV surge protection, we can also achieve the same through external surge protector for copper ports. Kindly clarify if our understanding is correct.	As we have very compact 6U rack which consist of active / passive elements other than switch. Hence external surge protector is not allowed. The provisions in bidding document remains unchanged
2	Section-I, Chapter-III	As per PMA policy , asking for foreign certification is restrictive. UL is a foreign certification. Request to exempt or put an equivalent Indian Standard for local OEMs.	The supplied materials shall utilized in outdoor environment in Mumbai Sub-urban and also under heavy surge of railway's RE area. The material is consignee inspected at site only . Hence only certified products are applicable. The provisions in bidding document remains unchanged
3	Section-I, Chapter-III	As per PMA policy , asking for foreign certification is restrictive. CE and FCC are foreign certifications and have legal bearing in USA and Europe. Request to exempt or put an equivalent Indian Standard for local OEMs.	The supplied materials shall utilized in outdoor environment in Mumbai Sub-urban and also under heavy surge of railway's RE area. The material is consignee inspected at site only . Hence only certified products are applicable. The provisions in bidding document remains unchanged
4	Section-I, Chapter-III	Our product is IPv6 compliant for which we can furnish n-house LABs confirming their application and Self-declaration stating compliance. However, this certification is not readily available with us as since it is issued by foreign body. Kindly allow as to bid .	The supplied materials shall utilized in outdoor environment in Mumbai Sub-urban and also under heavy surge of railway's RE area. The material is consignee inspected at site only . Hence only certified products are applicable. The provisions in bidding document remains unchanged
5	Section-I, Chapter-III	Most of the Equipment's is having only specific one Brand. So we recommend you to please add Equivalent brands with same configuration	as per clause 18 of Section-I chapter-III, bidders can provision existing OEM's material or else other OEM's material which has technical qualifications as mentioned in clause 18. However as RailTel has provisioned Wi-Fi at more than 5500 stations with controller of Cisco, Arub (HP) and Ruckus. Hence Access points of these OEM's are only applicable.
