Tenderer must have completed successfully and satisfactorily at least one single similar work costing not less than 35 % of the advertised tender value of work during the preceding three financial years (i.e. current financial year and three previous financial years) executed for Govt. /PSUs of State/Central. Offers not accompanied by work completion certificate from users in the format of Form no.2 will not be considered.

The total contract amount received by the tenderer during the last three years as per Audited balance sheet should be a minimum of 150% of advertised Tender Value of work. Offers not accompanied by Audited balance sheet will not be considered.
