(RailTel), Eastern Region invites Open e- Bids in two packet single stage system from established contractors with proven experience for the work of "Rectification of underground Optical Fibre cable and 6 quad cable by trenching, laying of HDPE Duct and 6 Quad cable, blowing/pulling of OFC cable in HDPE duct, Splicing/ jointing, termination and testing OFC cable and 6 Quad cable in Koderma – Rema (55 km) section of East Central Railway".
