Sub: Information to bidder for the tender of procurement of Layer 2 Access Switch , Small form-factor pluggable transceiver.

With reference to the above, In additional terms & conditions, the following changes have been done.

1. Testing: Testing shall be carried out at manufacturers/suppliers works place by RailTel's authorized representative. However, also the bidder shall arrange the demonstration of features like OAM, Q-in-Q, ERPS and CFM functionality etc. of the Switches at RailTel's Location (would be finalized later on after award of contract). Necessary switches & setup tools for the testing shall be arranged by the bidder with no additional cost to RailTel.

2. EMD: No provision of Earnest Money Deposit against the Bid. Bidder will have to be submit "Bid Security Declaration" in the format as below along with Bid.

2) If, after the award of work, I/We fail to accept LOA/LOI, or to sign the contract agreement or fail to submit performance guarantee or fail to commence the work within stipulated time period prescribed in tender documents;

OR

3) If I/We furnish any incorrect or false statement / information / document;

OR

4) If I/We hide any relevant information or do not disclose any material fact in the tender;

OR

5) If I/We commit any breach of integrity Pact;

I/We may be disqualified and banned for a period of three years and shall not be eligible to bid for future tenders in RailTel Corporation of India Ltd. for the period of three years from date of issue of such orders.

3. Eligibility Criteria;

A. Eligibility Criteria for OEM:

1. The Equipment offered by the OEM or equipment of the same series/family from the same OEM should have been satisfactorily working in Government/PSUs/Telecom Service Providers network for at least 12 months as on date of opening of tender, in India or Abroad. The certificates from the actual users will have to be submitted along with bid.

2. The OEM should have supplied at least 35% of the tendered value of the equipment offered or equipment of the same series/family during last preceding 3 financial years (i.e. current year and three previous financial years) as on opening of bid to Government/PSUs/Telecom Service Providers. OEM should submit self-certificate with proper contact detail of clients along with PO reference and amount supplied (Firm Name, Contact person, Designation, Telephone Number, Fax, Official mail id etc.). The same should be issued by authorized signatory.

3. The OEM should have proven facilities for Engineering, manufacture, assembly, integration and testing of switches and basic facilities with respect to space, Engineering, Personnel, Test equipment, Manufacture, Training, Logistic Supports for at least past three years in the country from where the proposed equipment are planned to be supplied. In case OEM is located outside India, it should have training, repair and service center facilities in India also. The certificates/Undertaking along with the complete address for the same will have to be submitted along with bid.

4. All the document of the OEM should be in English/Hindi language only. Document other than English/Hindi will not be entertained. However, Tech. Specification and details should be in English only.

5. OEM should not have been banned by any Govt./Semi Govt./PSU/State Govt./Any Telecom entity in India for the supply of the material. An undertaking to this effect signed by the authorized signatory to be submitted by OEM.

B. Eligibility Criteria for Bidder: Clause no. 4(A)& (B) Eligibility criteria Technical and Financial for bidder will be read as:

1. The Bidder should have executed project for supply and installation /commissioning of same or similar Category Products during preceding 3 financial years (i.e. current year and three previous financial years) as on opening of bid, as per following criteria:

- (i) Single order of at least 35% of estimated bid value;
- Or
- (ii) Two orders of at least 20% each of estimated bid value;
- Or
- (iii) Three orders of at least 15% each of estimated bid value.

Satisfactory Performance certificate issued by customers for the Purchase orders/Work orders Orders should be uploaded with bid. Supply of this value against a single rate contract, during above period, will also qualify for similar work.

2 The bidder should have minimum cumulative turnover of 150% of tendered value or above during the last 3 financial years (i.e. current year and/or three previous financial years). The bidder should provide Audited Balance Sheets / annual reports as documentary evidence and for current year, the Statutory Auditor's certificate for turnover of current year up to the date of bid opening for which Balance Sheet/P&L may not be available. In case of photocopy of Balance Sheet/P&L the same should be certified by Chartered Accountant as truecopy.

3 The Bidder should have registered office in India for a minimum period of 3 years as on scheduled date of bid opening. Certificate of Incorporation will have to be submitted.

- 4 The Bidder should have authorization specific to this tender from respective OEMs .
- 5 The Bidder or their promoters having equity stake or operating partnership in bidder, should not be holding valid License for Telecom service provider/ISP/NLD, Services License of Government of India for Telecom Operation.

Bid terms and conditions as per corrigendum documents will supersede the respective terms conditions in published GeM Bid.

4. Trusted Products ;

The offered equipment shall be "Trusted Products". The vendor/OEM shall submit declaration for compliance.

All others terms & conditions remained same.
