- i) Eligible MSEs are exempted from cost of Tender Document and EMD only. No other exemption will be given.
- ii) The rates should be inclusive of taxes, however, breakup of all the taxes charged by the bidder shall be shown separately. The tenderer has to submit the breakup of all taxes at the time of submission of their “Tax invoices” also. The tenderer has also to submit their GSTIN No. at the time of submissions of their “Tax invoices”. In addition to it, the contractor should submit copy of GSTIN registration certificate. PF Account & ESI registration no. should also be available with the contractor. All the statutory provisions have to be made by the contractor. In case of the successful tenderer is not liable to be registered under CGST/IGST/UTGST/SGST Act, the RailTel shall deduct the applicable GST from his/their bill under RCM and deposit the same to the concerned tax authority. Vendor should file GST return and transfer credit of GST in RailTel account as per GST procedure.

- iv) The offers shall be opened on above said date, in the presence of those bidders, who choose to be present. If the above said date happens to be a holiday, the same shall be opened on the next working day.
- v) Late/Delayed/incomplete tenders and tenders will be summarily rejected.
- vi) Tender document in PDF format will be send to the bidders. The tenderer shall download the tender document sign by the authorized representative of the tendering firm at all the pages of the document on printed copy and submit along with their offer.
- vii) Payment of cost of tender document shall be made in the form of Demand Draft/ Pay Order/ Banker's cheque drawn in favour of RailTel Corporation of India Ltd. payable at Kolkata.
