<sup>\*</sup>Small scale units registered with NSIC under single point registration scheme or registered as MSE (micro and small enterprises) under Udog Aadhar, the following exemption shall be available: (a) They shall be exempted from cost of tender document. (b) They shall also be exempted from submitting Bid Security Declaration (in lieu of EMD) (Kindly refer to clause No. 5.8 of instructions to tenderers and general conditions of contract (GCC)).
