- i) All the bidders will have to mandatorily upload the PDF of the duly filled price breakup document in the given format while participating in the bid. Price Evaluation will be done on the basis of the Lumpsum price quoted by the bidder in GeM Portal and price breakup will not have any impact on the ranking of the bidders. In case of any difference in Lumpsum price quoted by L-1 bidder in GeM portal and prices indicated by L-1 bidder in price break-up sheet uploaded in GeM portal, the rates in the price break-up document shall be proportionately adjusted based on the lumpsum price indicated in GeM portal. This adjustment shall be done for LD and payment purposes only (if bidder happens to be successful bidder for award of contract).
- ii) Components mentioned in Part A shall be hired on quarterly rental basis **and the FR device quantities mentioned is estimated , payment shall be as per actuals.**
- iii) Components mentioned in Part B shall be paid on actual consumption during the project implementation phase only.
- iv) Quoted price for Part A shall be minimum 85% of total quoted lumpsum cost (Part A +Part B). - vii) IT server hardware and storage of indicated configuration shall be provided by ONGC. In case, the bidder requires any additional material/ different configuration, he may quote under Part B (any other line items required for the project completion).
