Terms & Conditions:

1. The shortlisted BA has to ensure that no amount is to be deducted from VLE (Village Level Entrepreneur) Payment.
2. BA has to ensure timely disbursement of VLE (Village Level Entrepreneur) Payment
3. Compliance of Labour laws, Women compensation Act, EPF, ESIC, etc and any such type of statutory provision as applicable will be the responsibility of shortlisted BA. Any Legal dispute arising out of this and the expenses aroused from the same will have to be completely borne by the shortlisted BA.
4. Quoted margin shall be valid during the contract period from the date of commencement of contract and also during the extended period of contract, if any, and no modification in the quoted rate shall be entertained on whatsoever ground during the currency of contract.
5. The quoted service charges shall be exclusive of GST, from time to time and the same shall be charged in addition to the quoted rate to the BA.
6. Any tax in addition to GST will have to be borne completely by the shortlisted BA.
7. No service or administrative charges are applicable on this account.
