#### 1. Introduction

RailTel Corporation of India Limited (RailTel), a Government of India Public Sector Undertaking (PSU), invites Expressions of Interest (EOI) from qualified Supplier for providing One pair of Underground dark fiber for 15 years IRU lease for connecting Mumbai, Hyderabad and Chennai on express route along with drop at intermediatory cities. The selected partners will work with RailTel for strengthening of RailTel Network. The supplier should be a domestic partner, with a preference for indigenous companies in line with the Make in India initiative.

#### 2. Objective

The objective of this EOI is to identify potential suppliers to offer fiber connectivity diverse from RailTel existing routes and shortening the ring closure for better network uptime. Further strengthening of existing RailWire network in intermediatory Tier-2 cities.

#### 3. Scope of Work

The selected partners will be required to:

- i. Supply of dark fiber for connecting Mumbai, Hyderabad and Chennai express route upto RailTel PoPs/POI location
- ii. Supplier will extend the last mile to mutually identified RailTel sites to integrate with existing RailTel network
- iii. Offer colocation (power and space) for setting up amplifiers and junction nodes
- iv. Offer post-sales Operations and maintenance support of dark fiber and colocation for next 15 years
- v. Supply all relevant technical documentation, including KMZ, OTDR
- vi. Collaborate closely with RailTel to ensure seamless integration with the existing RailTel network.

#### 4. Evaluation Process

The EOIs will be evaluated based on the following criteria:

- i. Supplier should have all relevant approvals/ license from Government of India to lay/lease dark fiber
- ii. Suppliers should have Right of Way in their own name or completely owned subsidiary from respective authority for laying and maintenance of fiber for 15 years.
- iii. Express route connecting Mumbai-Chennai should have round trip delay less than or equal to 20 milliseconds and Chennai-Hyderabad & Mumbai-Hyderabad should have round trip delay less than or equal to 10 milliseconds.
- iv. Offered fiber should have fiber losses:

Beginning of Life: 0.3 db per km

o End of Life: 0.4 db per km

v. Path should cover intermediatory cities or nearby cities Pune and Gooty/Guntakal.

- vi. Colocation sites for amplifiers and junction nodes should not be more than 500 mtrs from the actual route
- vii. The expected handover and takeover of Fiber should be within 30 days of agreement signoff.
- viii. Evaluation of EOI will be done based on Total cost for the Mumbai, Hyderabad and Chennai express route upto RailTel PoPs/POI location as per the scope defined in EOI.

## 5. Service Level Agreement:

- i. Provide shall provide a DC power supply -48V to -60V at each collocated ILA/OADM sites. Power availability should be 99.99% uptime for each month.
- Provider shall provide a air-conditioner service at ILA & OADM sites with telecom Industry standards. Provide shall provide a guarantee for environmental availability of 99.99%
- iii. Provider shall provide a fiber uptime >= 98.5% OADM to OADM locations.

#### **6. Pricing:** Supplier shall provide commercial data:

- i. Fiber cost per km on IRU bases (15 years) & supplier shall also provide breakup cost for NLD, Metro & LMC routes.
- ii. ILA /OADM per rack unit (RU) cost and managed DC power (per 200w)- (Annual cost)
- iii. O&M on fiber route per km
- iv. Summary of each Dark Fiber path proposal
- v. Network uptime and MTTR
- vi. Detail of ILA & OADM locations including fiber distance between two adjacent locations of ILA/OADM.
