RailTel successfully organizes special campaign 2.0.

The campaign covered varied subjects like cleanliness, record management, space management, scrap disposal, expeditious disposal of pending public grievance cases etc.

RailTel organized special campaign 2.0 focusing on cleanliness, good governance and effective delivery of services. The campaign was undertaken in two phases-preparatory phase from 14-Sep-22 to 30-Sep-22 and implementation phase from 2-Oct-22 to 31-Oct-22 both at the level of Corporate Office and Regional Offices.
