2. The above list of provisionally suitable candidates has been prepared in the order of merit and age. In cases where two or more candidates have obtained the same marks, their relative ranking has been determined by age, with the older candidate placed higher in merit. Candidates availed age relaxation based on their community have been placed against their respective community.
3. Mere inclusion of a candidate's name in the provisional suitability list does not confer any right to appointment. Appointment is strictly subject to medical fitness and fulfilment of all other eligibility conditions and requirements specified in the recruitment rules and the vacancy notice.
4. At the time of reporting for medical examination, candidates shall submit details for the verification of character and antecedents in a duly filled attestation form and self-declaration stating that the educational qualifications, caste/community certificates, and other documents furnished by them are genuine and that there is no pending criminal case or adverse report against them. Appointment shall be provisional and is subject to verification of character and antecedents, caste/ community/ creamy layer/ income certificates, educational qualifications & experience, and in case any of the aforesaid verifications are found not verified, or not genuine or if any false information is furnished by the candidate in the attestation form/ self-declaration, the provisional appointment letter shall be cancelled forthwith and his services shall be terminated.
5. Candidates are required to meet the requisite medical standards, i.e., C-2 medical standards of the Indian Railway Medical Manual, as assessed by the medical authority appointed by RailTel Corporation of India Ltd. Candidates failing to meet these standards shall not be considered for appointment.
6. The Offer of Appointment and instructions for reporting to RailTel for the prescribed medical examination and submission of the attestation form, self-declaration, service bond, character certificate, and other documents confirming eligibility and related requirements, will be issued shortly to the above-mentioned provisionally suitable candidates through e-mail IDs provided by the candidate in their online application forms. Candidates are advised to regularly check their e-mail and the organization's official website for updates.

7. Candidates declared medically fit will be advised, through the e-mail IDs provided in their online application forms, to report to RailTel for joining on the date specified in the said communication. Generally, a period of two to four weeks is permitted for joining after completion of the medical examination.
8. Candidates employed in Government/ PSU/ Private organizations must produce a document confirming acceptance of their resignation from their previous employer at the time of joining; in the absence of such a document, they shall not be permitted to join RailTel services.
9. In case of any discrepancy, falsification, or non-fulfilment of eligibility criteria at any stage of the recruitment process or after appointment, the candidature shall be summarily rejected or the services of the candidate shall be terminated, as the case may be, and the decision of the recruitment authority shall be final and binding.
10. Candidates are cautioned against touts and job racketeers who may make false promises of securing employment in RailTel through influence or unfair means. RailTel Corporation of India Ltd. has not authorized any person or agency to act on its behalf in this regard.
