- 2. The supplementary list has been prepared after revision of cut-off marks, which have been lowered marginally to ensure adequate representation of eligible candidates. These additional candidates have thus been provisionally shortlisted for appearing in the interview, strictly in accordance with the approved criteria.
- 3. The supplementary list shall be read in continuation to and placed below the list already issued on 04.11.2025. All other terms and conditions mentioned in the earlier order shall remain unchanged and applicable to these candidates as well.
- 4. The shortlisted candidates shall be permitted to appear in the interview only after due verification of their eligibility and original documents as prescribed in the recruitment notification.
- 5. The shortlisted candidates shall be permitted to appear in the interview only after verification of their eligibility and original documents, including all certificates, mark sheets, experience certificates (if applicable), and any other documents as specified in the recruitment notification.
 - a. Mere inclusion of a candidate's name in the provisional list does not confer any right to appear in the interview or to claim selection.
 - b. Candidates provisionally shortlisted under the reserved category against reserved vacancies must produce a valid caste certificate, along with all other required documents, at the time of document verification/interview; failure to do so will render them ineligible to appear for the interview.
 - c. Candidates belonging to reserved categories but provisionally shortlisted against unreserved (UR) vacancies are also required to produce a caste certificate to claim benefits of reserve entegory.
 - d. In case of any discrepancy, falsification, or non-fulfilment of eligibility criteria at any stage, the candidature shall be summarily rejected, and the decision of the recruitment authority shall be final and binding.
- 6. Call letters for interviews will be issued in due course to the e-mail IDs provided by the candidates in their online application forms. Candidates are advised to regularly check their e-mail and the organization's official website for further updates.
