1. **ESSENTIAL QUALIFICATION, ELIGIBILITY CRITERIA, EXPERIENCE:** The applicant should satisfy eligibility criteria regarding educational/professional qualifications, length of experience, as given in **Annexure-I**. CTC for each post has also been indicated in **Annexure-I**.

Notes:-

- i) All mandatory educational/Professional qualifications should have been obtained from a recognized University/deemed University/ Autonomous institutes incorporated by an Act of Parliament of State Legislature in India or UGC Act or from Government approved/recognized institutions.
- ii) Experience gained after obtaining the minimum educational qualification prescribed for the post will be taken into consideration for ascertaining eligibility for the post.
- iii) Number of posts shown above are tentative and may change depending upon the project requirements. Applications finally empaneled after the due process of selection, will be inducted as per actual requirement and progress of the project from time to time.
- iv) Rule of reservation of posts for reserved community candidates would be applied as per govt. instructions of application of the scheme of reservation in work charged posts. Reservation generally would be applied to extant possible work charge post . However, if no eligible candidate of reserved Category selected in interview then post may be filled by other eligible candidate from any other category including unreserved category

2. **Age Limit and other conditions:** As detailed in **Annexure-II**.

3. **Schemes of selections:** Selections process involves Interview (Offline & Online) and medical examination.

4. The responsibility to establish eligibility for the post applied for with reference to all the prescribed eligibility conditions rests with the application. However, decision of RailTel Management shall be final.

5. Canvassing in any form will disqualify a candidate.

6. It shall be responsibility of the candidate to satisfy himself as to his fulfilling the eligibility criteria, and also to furnish correct, complete and desired information/ documents etc. Application would be required to furnish requisite documents so as to substantiate his/her eligibility for the post. No correspondence will be entertained from the candidates found ineligible or not shortlisted and thus not called for Interview.
