3. ESSENTIAL QUALIFICATION, ELIGIBILITY CRITERIA, EXPERIENCE:The applicant should satisfy eligibility criteria regarding educational/professional qualifications, length of experience and CTC for each post also be indicated in **Annexure-II.**
