Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Imposition of fine by NSE & BSE for the quarter ended 31st March, 2025

Dear Sir/ Madam,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is to inform that NSE and BSE have levied fine of Rs.14,04,200/- each (incl. GST) on the Company for the non-compliance with Regulation 17(1), 17(2A), 18(1), 19(1)/19(2), 20(2)/20(2A), 21(2) i.e. non-compliance for the composition of the Board and its committees for the guarter ended  $31^{st}$  March, 2025.

- 2. In this connection, we submit that the above non-compliance with respect to the Composition of the Board as well as various Committees are beyond the control of the Company. RailTel is a Government Company as per provisions of the Section 2(45) of the Companies Act, 2013, and in terms of the Articles of Association of the Company, the President of India vests with the power to appoint Directors (including Independent Director & Woman Independent Director) on the Board of RailTel. All Directors in RailTel are appointed by the Government of India through its Administrative Ministry, Ministry of Railways (MoR) and RailTel has no role to play in the appointment of any Director. Requests have already been made from time to time to the MoR for the appointment of requisite number of Independent Directors including Woman Directors on the Board of the Company.
- 3. Further, it may be brought out that the Company informed the BSE and NSE on 16<sup>th</sup> and 17<sup>th</sup> April 2025 about the reappointment of Dr. Subhash Sharma (DIN: 05333124) as Additional Director (Independent Director) with effect from 15<sup>th</sup> April 2025, pursuant to the Ministry of Railways' Order No. 2024/PL/57/38 dated 15/04/2025. Subsequently, on 14<sup>th</sup> and 15<sup>th</sup> May 2025, the Company informed about the appointment of Smt. Asha Sharma (DIN: 11104989) as Additional Director (Independent Director) with effect from 13<sup>th</sup> May 2025, in accordance with the Ministry of Railways' Order No. 2024/PL/57/38 Pt.-1 dated 13/05/2025.
- 4. Disclosure as per SEBI Circular No. SEBI/HO/CFD-PoD1/P/CIR/2023/123 dated July 13, 2023 is enclosed as Annex- A.
