# REPORT ON VIGILANCE AWARENESS WEEK-2017 RAILTEL CORPORATION OF INDIA LIMITED

Date: 14.11.2017

As per the CVCs directives, Vigilance Awareness Week was observed in RailTel from 30.10.2017 to 04.11.2017 in its true spirit and sense. The theme this year was "My Vision – Corruption Free India".

The week began with administering Integrity pledge to all RailTel officials from Corporate Office on 30.10.2017 at 11:00 am. The officials from Regional Offices also joined through RailTel's in-house Telepresence services (Video Conferencing).

During the week, a number of awareness activities were carried out and events organized involving RailTel's Officials as well as citizens. A brief of such activities is as under:

### 1. Awareness activities conducted in RailTel Corporation:

i) Vigilance Pledge: On 30/10/2017, RailTel officials undertook the vigilance as well as integrity pledge in a ceremony held in Board room at Corporate office, Gurgaon. The pledge was administered from Corporate Office along with the employees of Corporate Office and to the employees from various offices across the country joining in via RailTel's in-house Telepresence Services.



ii) Organizing lectures/talks: On the theme of 'My Vision – Corruption Free India', lecture from eminent personality with specialization on the subject was held by Sh. Rajiv Sinha, Head S&T, NCRTC (also ex. Director/RailTel) having vide experience in Contractual, procurement & vigilance matters on the topic at Corporate Office of RailTel in Gurgaon on 8.11.2017. He spoke on the need for development of culture of ethical working & integrity among all employees and gave suggestions to ensure transparency



& consistency in decision making. All employees of Corporate Office and Regions as well as Territory offices joined through Telepresence (Video Conferencing).


iii) Organising lecture/talk at regional offices: An internal talk/discussion session was organized at Northern Regional office of RailTel where senior management spoke on the subject, making the new and younger employees aware about importance of a preventive approach towards vigilance. Activities like tendering, procurement, bill passing and contract management were discussed with the employees.



- <u>iv)</u> Article writing: Articles were invited from employees of the corporation. After reviewing the same, checking for the quality of content, they were included and published in the RailTel Vigilance Bulletin. Awardees were selected for writing in English & Rajbhasha each.
- v) Quiz competition: A quiz competition was also organized on 03.11.2017 at the Corporate Office of RailTel, with participants from different departments of the corporate office taking part in it. The event was very well received and the top scorers were awarded for their knowledge and insights. The event was well attended and participated by almost all the employees present in the event.



vi) Poster making competition: A poster making competition was also organized with employees of RailTel participating from different departments and other Regional offices. The winners were finalized and awarded as well posters included in the Vigilance bulletin.





vii) Vigilance Bulletin: On this occasion, collection of articles from employees was published as RailTel's Vigilance Bulletin, which was released by Sh. Rajiv Sinha & Sh. Ashutosh Vasant, CMD & DPOM/RailTel on 08.11.2017. The bulleting covers various articles, poems, posters, etc. on this year theme both in English & Rajbhasha.



## 2. Awareness activities conducted by engaging with the youth:

On the theme of "My Vision – Corruption Free India", as per directions from Central Vigilance Commission, RailTel organized various activities by engaging with students in educational institutes covering 3 schools and 3 colleges across Delhi and Gurgaon. Debate, elocution, essay & poetry competitions were organized to engage with youth and spread awareness about being a vigilant citizen. The students from the educational institutes showed very keen interest and enthusiasm in participating in the event. The participating students were from different streams of study, they discussed various aspects of the topic and analysed the issue from different angles. The judges for all the events were appointed by respective college/school. Winning students were awarded and certificates of merit and certificates of participation were also distributed.
