'A', 'B' and Group 'C' level or in Central PSU's in levels E-0 to E-6, for deputation posting in RailTel Corporation for execution of National Optic Fiber Network Project in state of Gujarat and the 6 North Eastern States of Tripura, Meghalaya, Mizoram, Manipur, Arunachal Pradesh and Nagaland, on usual terms of deputation. The employees should be having experience of working in Signaling, Telecommunication, IT, Electrical or Civil Engg. domain.

- 2. The period of deputation will be initially for three years and can be extended by two more years if required in the exigencies of services.
- 3. The terms and conditions of deputation as stipulated in DOP&T OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010 are applicable. The employees on deputation will be entitled to draw parent cadre pay + usual deputation allowance. In addition they will be entitled for Transport allowance as applicable in parent cadre, perks & allowances as applicable to the deputationists in RailTel.

All the allowances taken together will be in the range Rs. 3000/- to Rs.9000/- per month, depending on the level of deputation post.

- 4. The employees on deputation will also be entitled for leased accommodation. Employees on deputation will have the option to choose either RailTel Medical attendance benefits or to continue Medical attendance benefit of his/her parent deptt.
- 5. Retired Central Govt/PSU employees, who worked in any of the position mentioned in para 1 above, at the time of retirement, may also be considered for re-engagement/re-employment in accordance with extant GOI guidelines.
- 6. Upper age limit
  - i. <u>For deputation posting</u>: The age of the applicant should be below 55 years as on the closing date of receipt of application.
  - ii. <u>For re-employment/re-engagement:</u> The age of the applicant should be below 62 years as on the closing date of receipt of application
